2 Hidden symmetries and supergravity solutions

7 The role of Killing and Killing-Yano tensors for studying the geodesic motion of
 8 the particle and the superparticle in a curved background is reviewed. Additionally,
 9 the Papadopoulos list [G. Papadopoulos, *Class. Quantum Grav.* **25**, 105016 (2008)]
 10 for Killing-Yano tensors in G structures is reproduced by studying the torsion types
 11 these structures admit. The Papadopoulos list deals with groups G appearing in the
 12 Berger classification, and we enlarge the list by considering additional G structures
 13 which are not of the Berger type. Possible applications of these results in the study
 14 of supersymmetric particle actions and in the AdS/CFT correspondence are outlined.

16 I. INTRODUCTION

17 Killing and Killing-Yano tensors^{1,2} and their conformal generalizations^{3,4} are a powerful tool
 18 in general relativity. When a given space time does admit such tensors, a classical constant of motion
 19 for particle probes moving in the background appears. This is reminiscent of the isometries, and it
 20 is often said that Killing and Killing-Yano tensors are the generators of hidden symmetries for the
 21 background. In fact, for the rotating black hole the separability of the Hamilton-Jacobi equation for
 22 a particle probe in the background^{5,6} is closely related to the presence of a conformal Killing tensor
 23 of rank two. This tensor admits a square root which is Killing-Yano,^{7,8} and which is a key ingredient
 24 for the separability of the Dirac equation corresponding to the rotating background.⁹

25 At the quantum level, Killing-Yano tensors are generators for non-anomalous symmetries,
 26 while for Killing tensors this is not the case. It is well known that when a bosonic particle in a given
 27 background is quantized then, for every globally defined Killing vector the background admits there
 28 corresponds an operator which commutes with the Hamiltonian (the curved Laplacian). But this
 29 assertion is false for Killing tensors in general, as the commutator of the corresponding operator
 30 with the Hamiltonian may not vanish.⁹ Nevertheless, when a Killing tensor admits a square root
 31 which is Killing-Yano, the anomaly vanishes identically.¹⁰ This is true for the rotating black hole
 32 discussed above, as well as for other geometries.

33 The similarities between the usual isometries and hidden symmetries discussed above raise
 34 the question whether or not Killing-Yano tensors do form an algebra. This issue was investigated
 35 in Refs. 11 and 12 where it was argued that the natural generalization of the Lie bracket for
 36 Killing vectors is the Schouten-Nijenhuis bracket for Killing tensors. The outcome is that Killing-
 37 Yano tensors do not form a Lie algebra in general, at least with this particular operation, but they
 38 do when some extra conditions are satisfied. An example is the requirement for the metric to
 39 be of constant curvature. For Killing tensors instead, an associated graded algebra was reported
 40 in Ref. 13 (see also Ref. 64).

41 The presence of hidden symmetries in a given background may give information about
 42 the algebraic type of the curvature. In four dimensions, the presence of a conformal and non-
 43 degenerate Killing-Yano tensor of rank two in a generic space time implies that the curvature is
 44 of type D in the Petrov classification.¹⁴⁻¹⁷ The local form of these metrics is known explicitly.¹⁸ The

generalization of the Petrov classification to higher dimensions was obtained in Refs. 19 and 127 and this classification allowed the authors of Ref. 20 to prove that any space admitting a closed non-degenerate conformal Killing-Yano (CKY) tensor is of type D. This was based in previous work done in Ref. 29. Furthermore, when the Einstein equations are imposed, these metrics become the Kerr-Taub-Ads family²² which generalize the old Myers-Perry solution.²³ But the converse of this statement is an open question, though some suggestions in this direction appear in Ref. 21.

Soon after the appearance of Ref. 20, the geodesic motion and the Hamilton-Jacobi and Dirac equations in these spaces were studied in Refs. 24–29. The outcome is that both equations are separable. Additionally, the role of conformal Killing-Yano tensors for studying geodesic motion in double spinning black rings was pointed out in Ref. 30, and a method for constructing conserved charges in asymptotically flat spaces by use of Killing-Yano tensors was given in Ref. 11 and in anti-de Sitter space times in Ref. 32.

Killing-Yano tensors also appear in other contexts of mathematical physics. For example, in the theory of gravitational instantons, they are known to generate Runge-Lenz type symmetries.^{33–38} The separability of the Dirac equation in the Kerr-Taub-Nut background was studied in Ref. 39, and formal properties of Dirac operators for spaces with hidden symmetries were pointed out in several works such as Refs. 40–43. Additionally, Killing-Yano tensors are generators for exotic supersymmetries in the spinning particle motion in a curved background.^{44–46} These are symmetries which mix bosonic and fermionic coordinates but whose square does not give the Hamiltonian.^{47,48} Further research related to the motion of particles of Abelian and non-Abelian charges in the presence of external fields have been performed in Refs. 47,49–54 and these techniques were further applied to derive $N = 4$ supersymmetric mechanics in a monopole background in Ref. 55. The relation between Killing-Yano and integrable systems was subsequently studied in Refs. 56–60, and applications related to string movement were found in Refs. 61 and 62. Novel geometries not necessarily Einstein were also obtained in Ref. 63.

Although their importance was understood long ago, till recent times few examples of spaces admitting Killing-Yano tensors were known. This situation changed in the last years. The problem of finding Killing-Yano tensors on spherically symmetric space times was studied in Ref. 68 and on pp-wave backgrounds in Ref. 69. The Killing tensors for the Melvin universe were characterized in Ref. 70. The local form of certain Lorentzian metrics admitting Killing-Yano tensors of higher order was studied in Ref. 71, and the presence of hidden symmetries in the Plebanski-Demianski family was studied in Ref. 72.

Recently, the problem of classifying the G structures do admit Killing-Yano tensors was investigated by Papadopoulos in Ref. 73. It is interesting that all the examples Papadopoulos is finding are Einstein or Ricci-flat. Furthermore, these spaces can be uplifted to an AdS supergravity solution. Since the constant of motions of rotating string configurations in these backgrounds are related to quantum numbers in a conformal dual quantum field theory, the study of hidden symmetries in these backgrounds may be of theoretical interest. The aim of the present work is to reproduce and enlarge this list.

The present work is organized as follows. In Sec. II, the role of Killing and Killing-Yano tensors as generators for hidden symmetries for the particle and the spinning particle in a given space time is reviewed. It also emphasized the fact that when a Killing tensor has a Killing-Yano “square root” the classical symmetries it generates are non-anomalous. In Sec. III, the conformal generalizations of Killing and Killing-Yano tensors and their role in finding solutions of Dirac equations in the curved background are briefly described. In Sec. IV, an attempt to generalize both notions for the motion of the Polyakov string and spinning string is presented. We are unable to find such a generalization unless some extra information about the string movement is given, and some examples realizing this situation are given explicitly. In Sec. V, the main features of G structures and their relation to special holonomy manifolds are briefly discussed, and all the cases of the Papadopoulos list are reproduced by means of the torsion formalism developed in Refs. 82–92. In addition, we analyze the presence of Killing-Yano tensors in almost contact structures and in $SO(3)$ structures in $SO(5)$ and in structures $H_k \subset SO(n_k)$, with $H_1 = SO(3)$, $H_2 = SU(3)$, $H_4 = Sp(3)$ and $H_8 = F_4$, following Refs. 116–118. Section VI contains the discussion of the results and their possible applications.

99 II. KILLING-YANO TENSORS AS EXOTIC SUPERSYMMETRIES

100 In the present section, some important aspects of Killing and Killing-Yano tensors and their role
 101 in finding conserved quantities for motion of a particle and spinning particle in a curved background
 102 are reviewed. It also emphasized the role of Killing-Yano as generators of exotic supersymmetries.
 103 Clear introductory notes are given for instance in Ref. 65, and this reference can be consulted for
 104 further details.

105 A. Killing tensors and the freely falling particle

106 A bosonic particle falling freely in a geodesically complete background $(M, g_{\mu\nu})$ is described
 107 by the following action:

$$S = \int_{\tau_0}^{\tau_1} L d\tau = \int_{\tau_0}^{\tau_1} g_{\mu\nu}(x) \dot{x}^\mu \dot{x}^\nu d\tau, \quad (2.1)$$

108 $\dot{x}^\mu = dx^\mu/d\tau$ being the derivative with respect to the proper time τ of the particle coordinate x^μ .
 109 The variation of (2.1) with respect to arbitrary infinitesimal transformations δx and $\delta \dot{x}$ is

$$\begin{aligned} \delta S &= \int_{\tau_0}^{\tau_1} \left[\frac{\delta L}{\delta x^\mu} - \frac{d}{d\tau} \left(\frac{\delta L}{\delta \dot{x}^\mu} \right) \right] \delta x^\mu d\tau + \int_{\tau_0}^{\tau_1} \frac{d}{d\tau} \left(\frac{\delta L}{\delta x^\mu} \delta x^\mu \right) d\tau \\ &= \int_{\tau_0}^{\tau_1} \left[-\delta x^\mu g_{\mu\nu} \frac{D\dot{x}^\nu}{D\tau} + \frac{d}{d\tau} \left(\delta x^\mu p_\mu \right) \right] d\tau, \end{aligned} \quad (2.2)$$

110 p_μ being the momentum of the particle

$$p_\mu = g_{\mu\nu} \dot{x}^\nu. \quad (2.3)$$

111 When the end points are fixed, i.e, when $\delta x^\mu = 0$, the total time derivative in (2.2) may be discarded.
 112 Then variation (2.2) is zero when the Euler-Lagrange equations

$$\frac{D\dot{x}^\mu}{D\tau} = \ddot{x}^\mu + \Gamma_{\nu\alpha}^\mu \dot{x}^\nu \dot{x}^\alpha = 0, \quad (2.4)$$

113 are satisfied. Here, $\Gamma_{\nu\alpha}^\mu$ denote the usual Christoffel symbols constructed in terms of the metric $g_{\mu\nu}$

$$\Gamma_{ij}^k = \frac{g^{kl}}{2} (g_{il,j} + g_{jl,i} - g_{ij,l}). \quad (2.5)$$

114 The first two members of the equations of motion (2.4) are the definition of the derivative $\frac{D\dot{x}^\nu}{D\tau}$.
 115 The vanishing of this derivative implies that the particle moves along a geodesic line in the curved
 116 background.

117 When the variations $\delta x^\mu = K^\mu$ do not have fixed end points the total derivative in (2.2)
 118 should not be discarded. In this case, by taking (2.4) into account it follows that the total variation
 119 of (2.2) is

$$\delta L = \frac{d}{d\tau} \left(K^\mu p_\mu \right). \quad (2.6)$$

120 If additionally $\delta x^\mu = K^\mu$ is such that this variation is zero, then it will be called a symmetry
 121 transformation of L . The formula (2.6) implies that the quantity

$$E_K = K_\mu \dot{x}^\mu, \quad (2.7)$$

122 is a constant of motion for the particle.

123 The most celebrated example of symmetries for (2.2) are those of the forms $\delta x^\mu = K^\mu(x)$, that
 124 is, the ones in which the variations are functions of the coordinates. The vanishing of (2.6) gives

$$\frac{d}{d\tau} \left(K_\mu \dot{x}^\mu \right) = \dot{x}^\nu \nabla_\nu K_\mu \dot{x}^\mu + K_\mu \frac{D\dot{x}^\mu}{D\tau} = 0.$$

But the last term is zero by (2.4) and the first one gives

$$\nabla_{(v} K_{\mu)} = 0, \quad (2.8)$$

where the parenthesis denote the usual symmetrization operation. Equation (2.8) shows that the vector field K_{μ} is Killing, that is, a local isometry of $g_{\mu\nu}$. Thus, for a particle moving along a geodesic in a given background $(M, g_{\mu\nu})$, there is a constant of motion for every isometry the background admits.

The isometries considered above are not the whole set of symmetries. The most general ones are of the form $\delta x^{\mu} = K(x, \dot{x})$, that is, transformation which are local with respect to the phase space coordinates (x^{μ}, \dot{x}^{μ}) . The generality of this ansatz follows from the fact that a dependence on higher order time derivatives such as \ddot{x} will reduce to combinations of (x, \dot{x}) by means of the equations of motion (2.4) and thus this dependence is redundant. If a Taylor-like expansion of the form

$$\delta x^{\mu} = K^{\mu} + K_{\alpha}^{\mu} \dot{x}^{\alpha} + K_{\alpha\beta}^{\mu} \dot{x}^{\alpha} \dot{x}^{\beta} + \dots, \quad (2.9)$$

with velocity independent tensors $K_{\mu_1 \dots \mu_n}^{\mu}(x)$ is proposed, then a calculation analogous to the one leading to (2.8) shows that if (2.9) will be a symmetry of the Lagrangian (2.1) when

$$\nabla_{(\mu} K_{\mu_1 \dots \mu_n)} = 0, \quad (2.10)$$

a condition which generalize (2.8). These tensors are known as Killing tensors and the quantities

$$c_n = K_{\mu_1 \dots \mu_n} \dot{x}^{\mu_1} \dots \dot{x}^{\mu_n}, \quad (2.11)$$

are constants of motion for the particle moving in the background. An obvious Killing tensor is the metric itself, that is, $K_{\mu\nu} = g_{\mu\nu}$. The corresponding conserved charge

$$H = \frac{1}{2} g^{\mu\nu} p_{\mu} p_{\nu}, \quad (2.12)$$

is the Hamiltonian for the particle.

A remarkable difference between Killing vectors and Killing tensors is that the first generate symmetries even for the quantum version of (2.2), while for tensors an anomaly may appear. The simplest quantum version of the particle motion is obtained by replacing the momentum p_{μ} with the operator ∇_{μ} and, for the scalar fields, the classical Hamiltonian (2.12) is replaced with the operator

$$\widehat{H} = \hbar^2 \nabla_{\mu} (g^{\mu\nu} \nabla_{\nu}), \quad (2.13)$$

which coincides with the Laplacian acting on scalar functions. Furthermore, any vector field K^{μ} is in correspondence with a quantum mechanical operator $\widehat{K} = K^{\mu} \nabla_{\mu}$ whose commutator with the Hamiltonian is

$$[\widehat{H}, \widehat{K}] = -2\hbar^2 K_{(\mu;\nu)} \nabla^{\mu} \nabla^{\nu} - \hbar^2 (2K_{(\mu;\nu)}{}^{;\nu} - K^{\nu}{}_{;\nu;\mu}) \nabla^{\mu} + \frac{\hbar^2}{4} \left(\frac{n-2}{n-1} \right) K^{\mu} R_{,\mu}. \quad (2.14)$$

From the last equation, it follows that for space times for which the vector K^{μ} is Killing the corresponding quantum mechanical operator will commute with the Laplacian. This means that Killing vectors generate true quantum symmetries. The situation is different for Killing tensors. As an example, consider operators of the form $\widehat{K}_{(2)} = \nabla_{\mu} (K^{\mu\nu} \nabla_{\nu})$. Then a lengthy calculation performed in Refs. 9 and 128 shows that

$$\begin{aligned} [\widehat{H}, \widehat{K}_{(2)}] &= 2\hbar^2 K^{\mu\nu;\sigma} \nabla_{(\sigma} \nabla_{\mu} \nabla_{\nu)} + 3\hbar^2 K^{(\mu\nu;\sigma)}{}_{;\sigma} \nabla_{\nu} \nabla_{\nu} \\ &+ \hbar^2 \left(\frac{1}{2} g_{\mu\nu} (K^{(\mu\nu;\lambda);\sigma} - K^{(\mu\nu;\sigma);\lambda}) - \frac{4}{3} K_{\mu}^{[\lambda} R^{\sigma]\mu} \right)_{;\sigma} \nabla_{\lambda}. \end{aligned} \quad (2.15)$$

If $K^{\mu\nu}$ is assumed to be a Killing tensor all the terms above will vanish except the last one. This can be paraphrased by saying that the classical symmetry that a Killing tensor generates will be anomalous, unless the integrability condition

$$(K_{\mu}^{[\lambda} R^{\sigma]\mu})_{;\sigma} = 0, \quad (2.16)$$

156 is satisfied. This condition holds for instance when the metric is Einstein $R_{ij} = \Lambda g_{ij}$, in particular,
 157 this is true for Ricci-flat metrics. This is also true when the Killing tensor is the square $K_{\mu\nu} = f_{\mu}^{\alpha} f_{\alpha\nu}$
 158 of a Killing-Yano tensor $f_{\mu\nu}$. The last situation will be discussed in Secs. II B–II E.

159 B. Supersymmetric extension of the bosonic particle

160 A supersymmetric generalization of the particle action (2.1) is the spinning particle.^{44–46} This
 161 was introduced as a suitable semi-classical approximation to the dynamics of a massive spin-1/2
 162 particle such as the electron. Its construction involves a fermionic extension M_{ξ} of the manifold M ,
 163 which requires the introduction of a new set of Grassmann variables ξ^{μ} with $\mu = 1, \dots, D$ with
 164 D being the dimension of the background in which the particle lives. For a particle moving in an
 165 Euclidean space with its flat metric $g = \delta_{ab} dy^a \otimes dy^b$, a supersymmetric extension is

$$L = \frac{1}{2} \delta_{ab} \dot{y}^a \dot{y}^b + \frac{i}{2} \delta_{ab} \dot{\xi}^a \dot{\xi}^b. \quad (2.17)$$

166 The corresponding action is invariant under the supersymmetry transformations

$$\delta y^a = -i \epsilon \xi^a, \quad \delta \xi^a = \dot{y}^a \epsilon, \quad (2.18)$$

167 with ϵ being an anti-commuting (Grassmann) number. More precisely, the transformation given
 168 above induce a variation on the Lagrangian which is proportional to a total time derivative and
 169 therefore it does not affect the equations of motion. The Euler-Lagrange equations derived from
 170 (2.17) are

$$\frac{d\dot{y}^a}{d\tau} = 0, \quad \frac{d\dot{\xi}^a}{d\tau} = 0. \quad (2.19)$$

171 Their meaning is transparent, the first one shows that the bosonic coordinates parameterize a line
 172 and that the fermionic variables ξ^{μ} are constant in time.

173 The Lagrangian (2.17) and the supersymmetry transformations (2.18) are referred to Cartesian
 174 coordinates y^a . For curvilinear coordinates x^{μ} (such as polar ones), one may write the metric in an
 175 n-bein basis $e^a = \partial_{\mu} y^a dx^{\mu}$ as $g = \delta_{ab} e^a \otimes e^b$. Then in a new coordinate system ξ^a defined through
 176 the relation $\xi^{\mu} = e^{\mu}_a \xi^a$ the action may be rewritten as

$$L = \frac{1}{2} g_{\mu\nu} \dot{x}^{\mu} \dot{x}^{\nu} + \frac{i}{2} g_{\mu\nu} \xi^{\mu} \frac{D\xi^{\nu}}{D\tau}, \quad (2.20)$$

177 and the supersymmetry transformation becomes

$$\delta x^{\mu} = -i \epsilon \xi^{\mu}, \quad \delta \xi^{\mu} = \dot{x}^{\mu} \epsilon. \quad (2.21)$$

178 In the last equation, the fermionic time derivative

$$\frac{D\xi^{\mu}}{D\tau} = \dot{\xi}^{\mu} + \dot{x}^{\nu} \Gamma_{\nu\lambda}^{\mu} \xi^{\lambda}, \quad (2.22)$$

179 has been introduced. With this definition it is straightforward to check that the Lagrangian (2.20)
 180 is invariant under (2.21). Furthermore, the fact that the curvature of the metric is trivial plays no
 181 role in this checking and thus the extension is valid for any metric $g_{\mu\nu}$. Therefore, (2.21) is a
 182 supersymmetric extension of the bosonic particle Lagrangian (2.1) in any background. The change
 183 of the action (2.20) with respect to a variation δx^{μ} and $\delta \xi^a$ is

$$\begin{aligned} \delta S = \int d\tau \left[-\delta x^{\mu} \left(g_{\mu\nu} \frac{D\dot{x}^{\nu}}{D\tau} + \frac{i}{2} \dot{\xi}^{\lambda} \xi^{\kappa} R_{\lambda\kappa\mu\nu} \dot{x}^{\nu} \right) + i \Delta \xi^{\mu} g_{\mu\nu} \frac{D\xi^{\nu}}{D\tau} \right. \\ \left. + \frac{d}{d\tau} \left(\delta x^{\mu} p_{\mu} - \frac{i}{2} \delta \xi^{\mu} g_{\mu\nu} \dot{\xi}^{\nu} \right) \right], \quad (2.23) \end{aligned}$$

where the momentum

$$p_\mu = g_{\mu\nu} \dot{x}^\nu - \frac{i}{2} \Gamma_{\mu\nu\lambda} \xi^\nu \xi^\lambda, \quad (2.24)$$

has been introduced, together with the variations

$$\Delta \xi^\mu = \delta \xi^\mu + \delta x^\nu \Gamma_{\nu\lambda}^\mu \xi^\lambda, \quad (2.25)$$

and the curvature tensor

$$R_{\mu\nu\lambda}^\kappa = \partial_\mu \Gamma_{\nu\lambda}^\kappa - \partial_\nu \Gamma_{\mu\lambda}^\kappa + \Gamma_{\lambda\mu}^\rho \Gamma_{\rho\nu}^\kappa - \Gamma_{\lambda\nu}^\rho \Gamma_{\rho\mu}^\kappa. \quad (2.26)$$

The equations of motion derived from (2.20) generalize (2.19) and can be casted in the following form:

$$\frac{D\xi^\mu}{d\tau} = 0, \quad \frac{D\dot{x}^\mu}{d\tau} = -\frac{i}{2} \xi^\lambda \xi^\kappa R_{\lambda\kappa}{}^\mu{}_\nu \dot{x}^\nu. \quad (2.27)$$

The last (2.27) in fact can be rewritten in terms of the ‘‘spin tensor’’ $S^{ab} = \xi^a \xi^b$ as

$$\frac{D\dot{x}^\mu}{d\tau} = -\frac{i}{2} S^{ab} R_{ab}{}^\mu{}_\nu \dot{x}^\nu, \quad (2.28)$$

which is analogous to the electromagnetic force with the tensor S^{ab} replacing the electric charge as coupling constant. Additionally, the first (2.27) imply that

$$\frac{DS^{ab}}{D\tau} = 0, \quad (2.29)$$

i.e, the tensor S^{ab} is covariantly constant.

C. Symmetries of the phase superspace

The next task is to characterize the symmetries of the spinning particle action (2.20). By analogy with (2.9), one may consider a general symmetry transformation of the superphase space (x, \dot{x}, ξ) . Higher order derivatives such as $\dot{\xi}$ should be absent due to the equation of motion (2.27), which are of first order in time derivatives of ξ . The generalization of (2.9) in this situation is an expansion of the form

$$\delta x^\mu = K^\mu(x, \dot{x}, \xi) = K^{(1)\mu}(x, \xi) + \sum_{n=1}^{\infty} \frac{1}{n!} \dot{x}^{\nu_1} \dots \dot{x}^{\nu_n} K_{\nu_1 \dots \nu_n}^{(n+1)\mu}(x, \xi), \quad (2.30)$$

$$\Delta \xi^\mu = S^\mu(x, \dot{x}, \xi) = S^{(0)\mu}(x, \xi) + \sum_{n=1}^{\infty} \frac{1}{n!} \dot{x}^{\nu_1} \dots \dot{x}^{\nu_n} S_{\nu_1 \dots \nu_n}^{(n)\mu}(x, \xi), \quad (2.31)$$

with $\Delta \xi^\mu$ defined in (2.25). If the end points are not fixed, as it is usually the case, the variation (2.23) will vanish if and only if

$$\frac{d}{d\tau} \left(\delta x^\mu p_\mu - \frac{i}{2} \delta \xi^\mu g_{\mu\nu} \dot{\xi}^\nu \right) = 0. \quad (2.32)$$

Note that in order to obtain this result the equations of motion (2.27) should be taken into account. By denoting the quantity in parenthesis (2.32) as M , it follows from (2.30) and (2.31) that it has an expansion of the form

$$M = M_0(x, \xi) + \sum_{n=1}^{\infty} \frac{1}{n!} \dot{x}^{\nu_1} \dots \dot{x}^{\nu_n} M_{\nu_1 \dots \nu_n}^{(n)}(x, \xi),$$

206 and is such that

$$K_{\mu_1 \dots \mu_n}^{(n)} = M_{\mu_1 \dots \mu_n}^{(n)}, \quad n \geq 1 \quad (2.33)$$

207

$$S_{\mu_1 \dots \mu_n \nu}^{(n)} = i \frac{\partial K_{\mu_1 \dots \mu_n}^{(n)}}{\partial \xi^\nu}, \quad n \geq 0. \quad (2.34)$$

208 Additionally, for an arbitrary function $M(x, \dot{x}, \xi)$ of the superphase space, a simple chain rule
209 together with the equations of motions (2.27) shows that

$$\frac{dM}{d\tau} = \dot{x}^\mu \left(\frac{\partial M}{\partial x^\mu} - \Gamma_{\mu\lambda}^\nu \dot{x}^\lambda \frac{\partial M}{\partial \dot{x}^\nu} + \xi^\lambda \frac{\partial M}{\partial \xi^\nu} \right) - \frac{i}{2} \xi^\lambda \xi^\kappa R_{\nu\mu\lambda\kappa} \frac{\partial M}{\partial \dot{x}^\nu}. \quad (2.35)$$

210 With the use of (2.33)–(2.35), the following recurrence relations are obtained for $n \geq 1$:

$$K_{(\mu_1 \dots \mu_n; \mu_{n+1})}^{(n)} + \frac{\partial K_{(\mu_1 \dots \mu_n}^{(n)}}{\partial \xi^\lambda} \Gamma_{\mu_{n+1})\kappa}^\lambda \xi^\kappa = \frac{i}{2} \xi^\lambda \xi^\kappa R_{\lambda\kappa\nu(\mu_{n+1}} K_{\mu_1 \dots \mu_n)}^{(n+1)\nu}, \quad n \geq 1. \quad (2.36)$$

211 For $n = 0$, one may define the quantity $K^{(0)}$ by the relation

$$S_\mu^{(0)} = i \frac{\partial K^{(0)}}{\partial \xi^\mu}, \quad (2.37)$$

212 and the equation for $S_\mu^{(0)}$ is equivalent to

$$K_{,\mu}^{(0)} + \frac{\partial K^{(0)}}{\partial \xi^\lambda} \Gamma_{\mu\kappa}^\lambda \xi^\kappa = \frac{i}{2} \xi^\lambda \xi^\kappa R_{\lambda\kappa\nu\mu} K^{(1)\nu}. \quad (2.38)$$

213 Note that, different for the bosonic case, the scalar $K^{(0)}$ is not an irrelevant constant, as it may depend
214 non-trivially on (x, ξ) by (2.38). Equations (2.34)–(2.38) characterize the local form of the symme-
215 tries for the superparticle action. These equations were derived, to the best of our knowledge, in
216 Refs. 47 and 48. The deduction given on those references relies in the Hamiltonian formalism, in
217 which the symmetries are interpreted in terms of quantities which commute with the Hamiltonian.
218 The Hamiltonian formalism is suitable for generalizing the notion of hidden symmetries when the
219 particle is in presence of gauge fields. This fact was exploited particularly in Refs. 47, 49–55.

220 D. Exotic supersymmetries

221 Although Eqs. (2.34)–(2.38) given above characterize the symmetries of the action (2.20), it
222 may be very hard to find explicit solutions for a given background. In the following some simple
223 cases will be considered, namely, the supersymmetries already introduced in (2.21) and the exotic
224 supersymmetries generated by the Killing-Yano tensors.

225 The simplest solution of the system (2.34)–(2.38) are symmetries which do not depend on the
226 fermionic variables. In this case, it is immediate to check that the resulting symmetry generators are
227 Killing tensors. One is the metric tensor itself $g_{\mu\nu}$ for which the associated conserved quantity is the
228 Hamiltonian

$$H = \frac{1}{2} g^{\mu\nu} P_\mu P_\nu, \quad (2.39)$$

229 with $P_\mu = g_{\mu\nu} \dot{x}^\nu$. In the Hamiltonian formalism, the time evolution of any dynamical quantity $F(x,$
230 $p, \xi)$ is given in terms of the Poisson bracket with (2.39)

$$\frac{dF}{d\tau} = \{F, H\}. \quad (2.40)$$

231 The fundamental Poisson brackets of the theory (2.20) are given by

$$\{x^\mu, p_\nu\} = \delta_\mu^\nu, \quad \{\xi^\mu, \xi^\nu\} = -i g^{\mu\nu}. \quad (2.41)$$

From these brackets it is straightforward to find that

$$\{p_\mu, \xi^\nu\} = \frac{1}{2} g^{\kappa\nu} g_{\kappa\lambda, \mu} \xi^\lambda, \quad \{p_\mu, p_\nu\} = -\frac{i}{4} g^{\kappa\lambda} g_{\kappa\rho, \mu} g_{\lambda\sigma, \nu} \xi^\rho \xi^\sigma. \quad (2.42)$$

In these terms, the following Poisson bracket for the tensor S^{ab} are found

$$\{S^{ab}, S^{cd}\} = \delta^{ad} S^{bc} + \delta^{bc} S^{ad} - \delta^{ac} S^{bd} - \delta^{bd} S^{ac}, \quad (2.43)$$

which justify the name ‘‘spin tensor’’. The space-like components S^{ab} represent the magnetic momentum and the time-like components are the electric momentum. Since it is expected that for free particles such as electrons, the electric momentum in the rest frame vanish identically, the time-like components should vanish identically. This condition may be imposed by requiring by implementing the subsidiary condition

$$\dot{x}^\mu \xi_\mu = 0, \quad (2.44)$$

after solving the equations of motion.^{47,48}

Another example of symmetries described by the system (2.34)–(2.38) are the supersymmetry transformations (2.21), and it will be instructive to check this out explicitly. By comparison between (2.21) and (2.30)–(2.31), it is found that the non-zero supersymmetry generators are

$$K_\mu^{(1)} = -i g_{\mu\nu} \xi^\nu, \quad S_{\mu\nu}^{(1)} = g_{\mu\nu}, \quad (2.45)$$

and the relation (2.34) is satisfied for all of them. Moreover, one has that

$$K_{\mu; \alpha}^{(1)} = g_{\mu\nu, \alpha} \xi^\nu - g_{\lambda\nu} \Gamma_{\mu\alpha}^\lambda \xi^\nu = g_{\mu\lambda} \Gamma_{\nu\alpha}^\lambda \xi^\nu,$$

where in the last the equality has been used that $g_{\mu\nu; \alpha} = 0$. With the use of the last formula it is deduced that (2.36) is satisfied. In addition, the left hand side of (2.38) is zero and by using the first (2.45) the right hand side vanish by the first Bianchi identity $R_{\mu[\nu\alpha\beta]} = 0$. Thus, the supersymmetry transformations (2.45) are solutions of Eqs. (2.34)–(2.38), which give an interesting consistency check. The conserved quantity related to the supersymmetry (2.21) is obtained from (2.32), the resulting Noether charge

$$Q = p_\mu \xi^\mu, \quad (2.46)$$

is known as the supercharge.

One may consider, in addition to the above examples, symmetries which mimics the supersymmetry property of mixing bosonic and fermionic coordinates. A natural ansatz for these symmetries is

$$\delta x^\mu = -i \epsilon f_a^\mu(x) \xi^a. \quad (2.47)$$

When the 1-forms f_a^μ are an n-bein e_a^μ basis for the metric, then the previous formula will represent a true supersymmetry (2.21). Otherwise, it will be a new type of symmetry, whose composition does not necessarily close to the Hamiltonian. For this reason, these are known as exotic supersymmetries. By comparing (2.30) and (2.31) with (2.47) and taking into account (2.34) the following generator are obtained:

$$K_\mu^{(1)} = -i g_{\mu\nu} f_a^\nu(x) e_\alpha^a \xi^\alpha, \quad S_{\mu\alpha}^{(1)} = g_{\mu\nu} f_a^\nu(x) e_\alpha^a. \quad (2.48)$$

In these terms, Eq. (2.36) is equivalent to

$$D_\mu f_\nu^a + D_\nu f_\mu^a = 0. \quad (2.49)$$

On the other hand, these cannot be the whole generators. If this were the case then the left hand side of Eq. (2.38) would be zero, but the right hand side is not unless $f_\nu^a = e_\nu^a$. Thus, a non-zero $K^{(0)}$ generator is present, and should be of the form

$$K^{(0)} = \frac{i}{3!} c_{abc} \xi^a \xi^b \xi^c, \quad (2.50)$$

263 the cubic dependence in ξ^a follows by noticing that the right hand of (2.38) is multiplied by a
 264 quadratic expression in the ξ^a variables and the generator $K_\mu^{(1)}$ in (2.48) is linear in the Grassmann
 265 variables. With this new generator Eq. (2.38) turns to be equivalent to

$$D_\mu c_{abc} = -R_{\mu\nabla ab} f_c^\nu - R_{\mu\nabla bc} f_a^\nu - R_{\mu\nabla ca} f_b^\nu. \quad (2.51)$$

266 In these terms, the new symmetry transformations are

$$\delta_f x^\mu = -i \epsilon f_a^\mu(x) \xi^a, \quad (2.52)$$

267

$$\delta_f \xi^\mu = \epsilon f_a^\mu(x) e_\nu^a \dot{x}^\nu + \frac{1}{2} \epsilon c^{\mu\nu\alpha} \xi_\nu \xi_\alpha. \quad (2.53)$$

268 A further simplification is obtained with the requirement that the transformations δ_f are superinvari-
 269 ant. This requirement means that the Poisson bracket between the supercharge and the generators of
 270 the exotic supersymmetry is zero. This condition imply that

$$f_\mu^a e_{\nu a} + f_\nu^a e_{\mu a} = 0. \quad (2.54)$$

271 The last formula implies that the tensor $f_{\mu\nu} = f_\mu^a e_{\nu a}$ is completely antisymmetric, thus a 2-form.
 272 Equation (2.49) is in this case equivalent to the following one:

$$f_{\mu\nu;\lambda} + f_{\lambda\nu;\mu} = 0. \quad (2.55)$$

273 Tensors satisfying (2.55) are known as Killing-Yano tensors. In brief, it may be stated that Killing-
 274 Yano tensors are the generators for superinvariant exotic supersymmetries. By taking into account
 275 (2.55) and the complete antisymmetry of $f_{\mu\nu}$, it follows that the gradient

$$f_{\mu\nu;\lambda} = \frac{1}{3}(f_{\mu\nu;\lambda} + f_{\nu\lambda;\mu} + f_{\lambda\mu;\nu}) = H_{\mu\nu\lambda}$$

276 is completely antisymmetric and thus it defines a 3-form $H_{\mu\nu\lambda}$. Then, the second covariant derivative
 277 of the last equation together with the Ricci identity and the antisymmetry of $f_{\mu\nu}$ give the following
 278 identity:

$$H_{\mu\nu\lambda;\kappa} = \frac{1}{2} \left(R_{\mu\nu\kappa}^\sigma f_{\sigma\lambda} + R_{\nu\lambda\kappa}^\sigma f_{\sigma\mu} + R_{\lambda\mu\kappa}^\sigma f_{\sigma\nu} \right). \quad (2.56)$$

279 The comparison between (2.56) and (2.51) shows the following identification:

$$c_{abc} = -2H_{abc} = -2e_a^\mu e_b^\nu e_c^\lambda H_{\mu\nu\lambda}. \quad (2.57)$$

280 In conclusion, the most general supersymmetry such as symmetries of the form (2.47) are obtained
 281 by the generators of the forms (2.52) and (2.53) and if these symmetries are superinvariants then they
 282 are completely determined in terms of Killing-Yano tensors of second rank, which are antisymmetric
 283 tensors satisfying (2.55). The exotic supersymmetry is defined by the formulas (2.54) and (2.57).^{47,48}

284 E. Squares of exotic symmetries

285 In the Hamiltonian formalism, where the fundamental brackets are (2.41) and (2.42), the action
 286 of symmetry transformation over a function of the superphase space $F(x, p, \xi)$ is given as

$$\delta F = i\{F, Q_s\}\epsilon, \quad (2.58)$$

287 Q_s being the conserved constant of motion. In particular, it can be checked that (2.30) and (2.31)
 288 are direct consequences of (2.58) together with the definition of the supercharge (2.46) and the
 289 fundamental Poisson bracket (2.41) and (2.42), which gives a consistency check. By using (2.42), it
 290 is seen that the supersymmetry generator Q satisfy

$$\{Q, Q\} = -2iH, \quad (2.59)$$

291 which is a well-known feature of the supersymmetry transformations. When r symmetries trans-
 292 formations δ_i with $i = 1, \dots, r$ are present, then there exist r conserved supercharges Q_i defined

by (2.32). Let us denote by Z_{ij} the following Poisson bracket:

$$\{Q_i, Q_j\} = -2 i Z_{ij}. \quad (2.60)$$

The time derivative of this quantity is

$$\frac{dZ_{ij}}{d\tau} = \{H, Z_{ij}\} = -2 i \{H, \{Q_i, Q_j\}\} = 2 i \{Q_j, \{H, Q_i\}\} + 2 i \{Q_i, \{Q_j, H\}\} = 0, \quad (2.61)$$

where in the last step the Jacobi identity together has been taken into account, together with the fact that $\{Q_i, H\} = 0$. The quantity Z_{ij} is the “charge” corresponding to the transformation $\delta_{ij} = \{\delta_i, \delta_j\}$ and the relation (2.61) imply that δ_{ij} is a symmetry transformation as well. In particular, if the symmetries δ_i are exotic supersymmetries of the form (2.52) and (2.53), then

$$\delta_{ij} x^\alpha = K_{ij}^{\alpha\mu} \dot{x}_\mu + \frac{i}{2} I_{ijab}^\alpha \xi^a \xi^b, \quad (2.62)$$

$$\delta_{ij} \xi^a = i I_{ijb}^{a\mu} \dot{x}_\mu \xi^b - G_{ijbcd}^a \xi^b \xi^c \xi^d, \quad (2.63)$$

the new quantities being defined as

$$\begin{aligned} K_{ij}^{\mu\nu} &= K_{ij}^{\nu\mu} = \frac{1}{2} \left(f_{ia}^\mu f_j^{\nu a} + f_{ja}^\mu f_i^{\nu a} \right), \\ I_{ijab}^\mu &= \left(f_{ib}^\nu D_\nu f_{ja}^\mu + f_{jb}^\nu D_\nu f_{ia}^\mu + \frac{1}{2} f_i^{\mu c} c_{jabc} + \frac{1}{2} f_j^{\mu c} c_{iabc} \right), \\ G_{ijabcd} &= \left(R_{\mu\nu ab} f_{ic}^\mu f_{jd}^\nu + \frac{1}{2} c_{iabc}^e c_{jcde} \right). \end{aligned} \quad (2.64)$$

The Killing-Yano equations (2.34)–(2.38) for f_{jd}^ν and c_{abc} imply the following relations for the new quantities:^{47,48}

$$K_{(\mu\nu;\lambda)} = 0,$$

$$D_{(\mu} I_{\nu)ab} = R_{ab(\mu} K_{\nu)}, \quad (2.65)$$

$$D_\mu G_{abcd} = R_{\lambda\mu[ab} I_{cd]}^\lambda.$$

The first (2.65) shows that the entries of the matrix $K_{ij\mu\nu;\lambda}$ are all Killing tensors. This result is well known, the “square” of two Killing-Yano tensors gives a Killing tensor, a result which was obtained in the context of general relativity in Ref. 8. Furthermore, it can be shown by taking into account (2.55) that this Killing tensor satisfies the integrability condition (2.16) and therefore give rise to a symmetry which is free of anomalies, a result that was anticipated by Carter in Refs. 9 and 10.

III. CONFORMAL GENERALIZATIONS OF KILLING AND KILLING-YANO TENSORS

The relations described above between Killing and Killing-Yano tensors can be generalized to tensors of higher order. Additionally, conformal generalizations of these tensors may be constructed as well.⁶⁶ For example, the conformal generalization of a Killing vector is a vector field K which satisfy

$$L_K g_{\mu\nu} = \lambda g_{\mu\nu},$$

with λ being a constant and L_K the standard Lie derivative along K . These are vectors with a flow preserving a given conformal class of metrics. When λ goes to zero, the usual definition of a Killing vector is obtained. Similarly, a conformal Killing tensor is

$$\nabla_{(\nu} K_{\mu_1 \dots \mu_n)} = g_{\nu(\mu_1} \tilde{K}_{\mu_2 \dots \mu_n)}, \quad (3.1)$$

with $\tilde{K}_{\mu_2 \dots \mu_n}$ is the tensor defined by taking the trace on both sides. The limit $\lambda \rightarrow 0$ reduce to the usual definition of a Killing tensor.

322 Killing-Yano tensors also admit a generalization to orders higher than two, and conformal
 323 generalizations.^{3,4} To see this one may note that Eq. (2.55) defining Killing-Yano tensors may be
 324 rewritten as

$$\nabla_X f = \frac{1}{p+1} i_X df, \quad (3.2)$$

325 with $p = 2$ and X an arbitrary vector field. For an arbitrary p -form, we will say that is Killing-Yano if
 326 (3.2) is satisfied. The conformal generalization are the tensors f defined by the following equation:^{3,4}

$$\nabla_X f = \frac{1}{p+1} i_X df - \frac{1}{n-p+1} X^\flat \wedge d^* f, \quad (3.3)$$

327 which are known as conformal Killing-Yano tensor. Here, X^\flat is the dual 1-form to the vector field X
 328 and d^* is the adjoint of d . This adjoint operation can be defined in terms of the Hodge star $*$, whose
 329 square is ± 1 depending on the values of p and n and the signature of the metric. More precisely,

$$**X = (-1)^{p(n-p)} \epsilon X \quad \epsilon = \frac{\det g}{|\det g|}.$$

330 In these terms, the adjoint of d is given by $d^* f = (-1)^p *^{-1} d * f$ with $*^{-1} = (-1)^{p(n-p)} \epsilon *$. Note
 331 that if $d^* f = 0$, the CKY tensor reduces to a usual KY tensor. In terms of two CKY tensors of the
 332 same order one may construct a symmetric 2-tensor

$$K_{\mu\nu} = (f^1)_{\mu\mu_1\dots\mu_n} (f^2)^{\mu_1\dots\mu_n}_\nu + (f^2)_{\mu\mu_1\dots\mu_n} (f^1)^{\mu_1\dots\mu_n}_\nu, \quad (3.4)$$

333 which, by virtue of (3.2), is a conformal Killing tensor. This relation generalize the first (2.65) for
 334 the conformal case. In particular, if the f^i are Killing-Yano, then (3.4) will be Killing and we will
 335 recover results mentioned above.

336 A particular and important example realizing (3.3) are principal conformal Killing-Yano tensors
 337 for $p = 2$, which are relevant in black hole physics. These are non-degenerate and closed p -forms,
 338 i.e., $df = 0$, and are solutions of the following equation:

$$\nabla_X f = X^\flat \wedge \xi^\flat, \quad \xi_\nu = \frac{1}{n-1} \nabla_\mu f_\nu^\mu. \quad (3.5)$$

339 Here, the vector ξ_μ satisfies the following equation:

$$\xi_{(\mu;\nu)} = -\frac{1}{n-2} R_{\lambda(\mu} f_{\nu)}{}^\lambda,$$

340 with $R_{\lambda\mu}$ the Ricci tensor of the background. It follows that for Ricci-flat or Einstein spaces this
 341 vector will be Killing. These tensors were considered in Ref. 20 and it was proved in that reference
 342 that any space admitting a conformal and principal Killing-Yano tensor of order two is of type
 343 D in the generalized Petrov classification of Ref. 19. Furthermore, when the Einstein equations
 344 are imposed, these metrics become the Kerr-Taub-Ads family.²² Higher dimensional Killing-Yano
 345 tensors were considered in the context of black holes physics in Ref. 67.

346 A. Quantum symmetries from Killing-Yano tensors

347 In view of the results discussed in Secs. II A–II E, Killing-Yano tensors seem to be more
 348 fundamental than Killing tensors as they generate true symmetries for the movement of the free
 349 particle in a given curved background. In other words, they generate operators which commute with
 350 the wave operator on the curved background. An additional property, which makes them specially
 351 interesting, is that they also generate operators which commute with the Dirac operator for the given
 352 background, thus they generate quantum symmetries for spin 1/2 particles moving in the space
 353 time^{40–43} (see also Ref. 74).

354 Let us assume that it is possible to define a Dirac spinor structure in the curved background.
 355 These spinors carry an irreducible representation of the Clifford algebra. The elements of this algebra
 356 are identified with forms and the following convention is adopted:

$$e^a e^b + e^b e^a = g^{ab}.$$

With this in hand, the Dirac operator on a curved background is defined as

$$D = e^a \nabla_{X_a}, \quad (3.6)$$

with e^a a tetrad basis for the metric g_{ab} of the background. In these terms one may construct the following operators acting on spinors:

$$D_f = L_f - (-1)^p f D, \quad (3.7)$$

with

$$L_f = e^a f \nabla_{X_a} + \frac{p}{p+1} df - \frac{n-p}{n-p+1} d^* f$$

being an operator constructed in terms of a p -form whose components are $f_{\mu_1 \dots \mu_p}$. The graded commutator

$$\{D, D_f\} = DD_f + (-1)^p D_f D,$$

calculated between the operators (3.7) and (3.6) is given by

$$\{D, D_f\} = RD, \quad R = \frac{2(-1)^p}{n-p+1} d^* f D. \quad (3.8)$$

For a Killing-Yano tensor, one has that $d^* f = 0$ and thus $R = 0$. This means that there exist operator for which the graded commutator with the Dirac operator is zero for every Killing-Yano tensor the background admits. These properties were extensively studied for instance in Ref. 41.

IV. KILLING-YANO TENSORS IN STRING AND SUPERSTRING BACKGROUNDS

As Killing and Killing-Yano tensors are generators for hidden symmetries for the particle and superparticle one may ask if there exist the analogous structures for the movement of a string or a superstring in a given background. The present section deals with this problem.

A. Hidden symmetries for the bosonic string

The movement of the bosonic string is described in terms of the Polyakov action. Consider a D -dimensional space time M with metric $g_{\mu\nu}$ a two-dimensional worldsheet Σ parameterized by coordinates (σ^1, σ^2) , and suppose that there is an embedding ϕ from $\phi: \Sigma \rightarrow M$ such that $x^\mu = x^\mu(\sigma_i)$. The Polyakov action is then expressed as

$$S_p = T \int d^2 \Sigma \sqrt{-h} h^{ab} g_{\mu\nu} \partial_a x^\mu \partial_b x^\nu, \quad (4.1)$$

where h_{ab} is a metric in the two-dimensional worldsheet Σ . By use of the equation of motion of h^{ab} and replacing the result into (4.1), the Nambu-Goto string is obtained. By denoting $\sigma^1 = \tau, \sigma^2 = \sigma, \dot{x}^\mu = \partial_\tau x^\mu$, and $x'^\mu = \partial_\sigma x^\mu$ the Nambu-Goto action reads

$$S_{NG} = -T \int d^2 \Sigma \sqrt{(g_{\mu\nu} \dot{x}^\mu x'^\nu)^2 - (g_{\mu\nu} \dot{x}^\mu \dot{x}^\nu)(g_{\mu\nu} x'^\mu x'^\nu)}. \quad (4.2)$$

The Polyakov action (4.1) is invariant under diffeomorphisms and Weyl transformations $h^{ab} \rightarrow \Omega^2 h^{ab}$. The content of the theory are the bosonic coordinates x^μ and the three-components h^{ab} of the Riemann surface metric, which depends functionally on the two coordinates (σ^1, σ^2) parameterizing the surface.

In order to find the general symmetries for the Polyakov action, one should consider a variation $\delta\sigma$ and $\delta\tau$ and field variations δh^{ab} and δx^μ of the bosonic fields defined at the same point. The total variation of the bosonic fields is

$$\Delta h^{ab} = \delta h^{ab} + \partial_i h^{ab} \delta\sigma^i, \quad \Delta x^\mu = \delta x^\mu + \partial_i x^\mu \delta\sigma^i. \quad (4.3)$$

386 The variation of the action (4.1) with respect to (4.3) inside a region R is given by

$$\begin{aligned} \delta S = \int_R d^2 \Sigma \left\{ \left[\frac{\delta L}{\delta x^\mu} - \partial_a \left(\frac{\delta L}{\delta (\partial_a x^\mu)} \right) \right] \delta x^\mu + \frac{\delta L}{\delta h^{ab}} \delta h^{ab} \right\} \\ + \int_R d^2 \Sigma \partial_a \left(\frac{\delta L}{\delta (\partial_a x^\mu)} \delta x^\mu + L \delta \sigma^a \right). \end{aligned} \quad (4.4)$$

387 Explicitly this variation is

$$\begin{aligned} \delta S = \int_R d^2 \Sigma \left[2\sqrt{h} h^{ab} g_{\nu\kappa, \mu} \partial_a x^\nu \partial_b x^\kappa - \partial_a \left(\sqrt{h} h^{ab} g_{\mu\nu} \partial_b x^\nu \right) \right] \delta x^\mu \\ + \int_R d^2 \Sigma \sqrt{h} \left(g_{\nu\kappa} \partial_a x^\nu \partial_b x^\kappa - \frac{1}{2} h_{ab} h^{cd} g_{\nu\kappa} \partial_c x^\nu \partial_d x^\kappa \right) \delta h^{ab} \\ + \int_R d^2 \Sigma \partial_a \left(\sqrt{h} h^{ab} g_{\nu\kappa} \partial_b x^\kappa \Delta x^\nu \right). \end{aligned} \quad (4.5)$$

388 The Euler Lagrange equations are obtained by considering variations that vanish on the boundary
389 ∂R of the region R . For Riemann surfaces, one may bring h_{ab} to a diagonal metric η_{ab} by a conformal
390 transformation. The equations of motion then are

$$\eta^{ab} \partial_a \partial_b x^\nu + \eta^{ab} \Gamma_{\kappa\mu}^{\nu} \partial_a x^\kappa \partial_b x^\mu = 0, \quad (4.6)$$

391 which generalize the geodesic equation for a two-dimensional motion. Alternatively, the last system
392 of equations may be expressed as

$$\eta^{11} \frac{D\dot{x}^\mu}{D\tau} + \eta^{22} \frac{Dx'^{\mu}}{D\sigma} = 0, \quad (4.7)$$

393 and the conformal constraints reduce to

$$g_{\nu\kappa} (\dot{x}^\nu x'^{\kappa} + x'^{\nu} \dot{x}^\kappa) = 0,$$

394

$$\eta^{11} g_{\nu\kappa} \dot{x}^\nu \dot{x}^\kappa + \eta^{22} g_{\nu\kappa} x'^{\nu} x'^{\kappa} = 0. \quad (4.8)$$

395 If instead one consider coordinate dependent variations $\delta x^\mu = K^\mu$ which do not vanish on the
396 boundary and which leave the action invariant, then the vanishing of the variation (4.5) together with
397 the equations of motion (4.7) imply that

$$\eta^{11} \partial_\tau (\dot{x}^\mu K_\mu) + \eta^{22} \partial_\sigma (x'^{\mu} K_\mu) = 0.$$

398 By use of the equation of motions (4.7), the last formula reduce to

$$\eta^{11} \dot{x}^\nu \dot{x}^\mu \nabla_{(\nu} K_{\mu)} + \eta^{22} x'^{\nu} x'^{\mu} \nabla_{(\nu} K_{\mu)} = 0. \quad (4.9)$$

399 By comparing this with the second (4.8), it follows directly the following solution of this equation

$$\nabla_{(\nu} K_{\mu)} = \lambda g_{\mu\nu}, \quad (4.10)$$

400 λ being an arbitrary constant. For $\lambda = 0$, the vector K_μ is Killing, otherwise it is a conformal Killing
401 vector. Thus, conformal Killing vectors generate constants of motion for the Nambu-Goto string.

402 In order to find generalizations of Killing tensors for the Polyakov string, one may postulate
403 a symmetry transformation which depends also on the worldsheet derivatives of the background
404 coordinates, that is, $\delta x^\mu = K^\mu(x, \cdot, x, x')$. Then, by performing a Taylor-like expansion of the form

$$\delta x^\mu = K^\mu + K_{\nu\alpha}^\mu \dot{x}^\nu x'^{\alpha} + \dots, \quad (4.11)$$

405 the vanishing of the action (4.5) gives the following system to solve:

$$\eta^{11} \partial_\tau (\dot{x}^\mu \dot{x}^\nu x'^{\alpha} K_{\mu\nu\alpha}) + \eta^{22} \partial_\sigma (x'^{\mu} \dot{x}^\nu x'^{\alpha} K_{\mu\nu\alpha}) = 0.$$

We attempted to solve this system and unfortunately, we find it very difficult to deal with. Recall that the main task is to find a geometrical object which give rise to a conserved quantity for any solution of the equation of motions. But we have found that, due to the mixing of derivatives in τ and σ , additional conditions on the equations of motion should be imposed in order to find conserved charges. This difficulty suggest, at least to us, that in order to find a hidden symmetry for a string movement, one should partially specify the way that the string evolves. For instance, one may be studying a spinning or a rotating string, or other similar configurations such as a wound string, and after specifying this behavior one may search for hidden symmetries.

To give an example about specifying the string movement let us consider again the Nambu-Goto string (4.2), which can be rewritten in equivalent fashion as

$$S = \int_{\sigma} d^2 \Sigma \sqrt{-\det(g_{\mu\nu} \partial_a x^\mu \partial_b x^\nu)}. \quad (4.12)$$

When the background metric $g_{\mu\nu}$ admits a globally defined Killing vector field V , then one may rewrite the induced metric $\hat{g}_{\mu\nu}$ on M/G , with G being the orbits of the Killing vector, as follows:

$$\hat{g}_{\mu\nu} = g_{\mu\nu} - \frac{\xi^\mu \xi^\nu}{g_{00}}. \quad (4.13)$$

If additionally, it is assumed that the string world surface is foliated by the orbits G of the Killing vector,⁶¹ then the Nambu-Goto action reduce to

$$S = \int_{\sigma_0}^{\sigma_1} \left(\frac{1}{N} \tilde{g}_{\mu\nu}(x) x'^{\mu} x'^{\nu} + N \right) d\sigma, \quad (4.14)$$

where the lapse function N has been introduced and which, under a reparameterization $\sigma' = \sigma'(\sigma)$, transforms as

$$N \rightarrow N' = \frac{d\sigma}{d\sigma'} N. \quad (4.15)$$

The behavior (4.15) insures the action (4.14) to be reparameterization invariant. Here, we have denoted $\tilde{g}_{\mu\nu} = g_{00} \hat{g}_{\mu\nu}$. From here it follows that when the string world surface is foliated by the orbits of a Killing vector the action reduce to a one-dimensional effective one with an induced metric $\tilde{g}_{\mu\nu} = g_{00} \hat{g}_{\mu\nu}$.⁶¹ This is a particle limit, and the Killing and Killing-Yano induced metric admits will generate hidden symmetries for the motion of such particle, or massless string.

B. Hidden symmetries for the spinning string

Considerations analogous to the above hold for the movement of the spinning string, whose action in the conformal gauge is

$$S = \int d\sigma^2 \left(\frac{1}{2} \eta^{ab} g_{\mu\nu} \partial_a x^\mu \partial_b x^\nu - \frac{i}{2} \bar{\psi}^A \rho^a \frac{D\psi_A}{D\sigma_a} \right), \quad (4.16)$$

with ρ^a being the usual Dirac matrices in two dimensions. The action given above is supplemented with the vanishing on the worldsheet of the energy momentum tensor T_{ab}

$$T_{ab} = g_{\mu\nu} \partial_a x^\mu \partial_b x^\nu + \frac{i}{2} g_{\mu\nu} \psi^\mu \rho_{(a} \frac{D\psi^\nu}{D\sigma^{b)}} - \frac{\eta^{ab}}{2} \left(g_{\mu\nu} \partial_c x^\mu \partial^c x^\nu + \frac{i}{2} \psi^A \rho^c \frac{D\psi_A}{D\sigma^c} \right) = 0, \quad (4.17)$$

and the supercharge Q_a

$$Q_a = \frac{1}{2} \rho^b \rho^a \psi_\mu D_a x^\mu = 0. \quad (4.18)$$

In presence of a Killing vector V^μ , the induced metric on M/G is (4.13). In order to reduce the action to a particle, one may assume that the spinning string movement is foliated by the orbits of the

435 Killing vector, as done above. Also the further requirement

$$V_\mu \partial_\sigma x^\mu = 0, \quad \mathfrak{L}_V \psi^\mu = 0, \quad (4.19)$$

436

$$\psi^\mu V_\mu = g_{00} \Upsilon,$$

437 Υ being a constant spinor, implies the decomposition $\psi^\mu = \xi^\mu + V^\mu \Upsilon$. Under these assumptions
438 the action (4.16) reduce to $S = I \Delta \tau$ with

$$I = \int d\sigma \left(\frac{1}{2} \tilde{g}_{\mu\nu} \dot{x}^\mu \dot{x}^\nu + \frac{i}{2} \tilde{g}_{\mu\nu} \xi^\mu \frac{D\xi^\nu}{D\sigma} \right),$$

439 with the dots denoting derivatives with respect to σ .⁶² The last expression is equivalent to (2.20)
440 with the induced metric $\tilde{g}_{\mu\nu}$. We have then reproduced the particle limit of the spinning string found
441 in Ref. 62 and the Killing-Yano tensors, the induced metric admits will generate hidden symmetries
442 for the motion of this configuration of the spinning string.

443 V. KILLING-YANO TENSORS AND G-STRUCTURES

444 Our next task is to investigate the presence of Killing-Yano tensors in G structures. These
445 structures play an important role for constructing supergravity solutions and appear naturally when
446 studying special holonomy manifolds. As is well known, the holonomy group of a metric g defined
447 over an oriented n -dimensional manifold M is $SO(n)$ or a subgroup $G \in SO(n)$. The possible holonomy
448 subgroups were classified by Berger in Ref. 76. The groups we will be concerned with are $Spin(7)$,
449 G_2 , $Sp(n)$, $Sp(n) \times Sp(1)$, $U(n)$, and $SU(n)$ and it turns out that metrics with these holonomy groups
450 are always Einstein or Ricci-flat. For the Ricci-flat case, the reduction of the holonomy to G is
451 equivalent to the presence of a set of p-forms, which will be denoted from now as σ_p^G , which are
452 constructed in terms an n-bein basis e^a for g and each of which is invariant under the action of G and
453 also covariantly constant with respect to the Levi-Civita connection. The situation is a bit different
454 for the Einstein case, as we will see below.

455 To give an example, consider a 7-metric $g_7 = \delta_{ab} e^a \otimes e^b$ with e^a a 7-bein basis and $a, b = 1,$
456 $\dots, 7$. Then the following three form

$$\phi = c_{abc} e^a \wedge e^b \wedge e^c, \quad (5.1)$$

457 constructed in terms of the multiplication constants c_{abc} of the imaginary octonions, is invariant
458 under a G_2 rotation of the basis e^a . This follows from the fact that $G_2 \in SO(7)$ is the automorphism
459 group of the imaginary octonions. The set composed by the metric g_7 and the 3-form (5.1) is called
460 a G_2 structure. In general, a G structure is composed by a Riemannian metric g together with a
461 complete set of G invariant p-forms σ_p^G . For $G = G_2$, the additional condition $\nabla_X \phi = 0$ for an
462 arbitrary vector field X implies that the parallel transport of the e^a around a closed loop will induce
463 a rotation $e^a = R_b^a e^b$ which leaves ϕ invariant. Thus, in this case the holonomy will be G_2 or a
464 subgroup of G_2 . The resulting equations are equivalent to the differential system $d\phi = d^* \phi = 0$.^{77,78}
465 Similar consideration follows for Ricci-flat G structures. The condition $\nabla \sigma_p^G = 0$ will imply that
466 the holonomy is reduced to G or to a smaller subgroup.

467 An important tool for studying G holonomy manifolds is the torsion formalism, which is a
468 method for studying obstructions for a metric g to be of G holonomy and was reviewed in Ref. 82
469 (see also Ref. 102). The roots of this formalism dates, to the best of our knowledge, from the work⁷⁵
470 about hypercomplex structures, and it can briefly be described as follows. The Berger holonomy
471 groups G are embedded in $SO(n)$ and this imply algebra $so(n)$ can be represented schematically as
472 $so(n) = g \oplus g^\perp$. For Ricci-flat holonomy groups, this induce the following decomposition of the
473 Levi-Civita connection:

$$\nabla = \nabla^g + \nabla^{g^\perp} = \nabla^g + \frac{1}{2} T, \quad (5.2)$$

474 the component ∇^g satisfying $\nabla_X \sigma_p^g = 0$. The equality (5.2) can be taken as the definition of the
475 torsion tensor T_{jk}^i , which corresponds to the component ∇^{g^\perp} . When this tensor vanish identically

the holonomy is G or a smaller subgroup, as the connection ∇^s will coincide with the Levi-Civita connection. Heuristically, the torsion measures the failure of the holonomy for being G .

The torsion T_{ijk} will play a significant role in the following discussion and it may be instructive to describe it with an explicit example. Let us recall that in four dimensions the isomorphism $SO(4) \simeq SU(2)_L \times SU(2)_r$ induces the decomposition $6 \rightarrow 3 + 3$ of a Maxwell tensor F_{ab} into self-dual and anti-self dual components. Consider now the analogous for the group $G = G_2$ discussed above. An antisymmetric tensor A_{ab} transform as the adjoint of group $SO(7)$, which has 21 generators, and the embedding of G_2 into $SO(7)$ induce the decomposition $21 \rightarrow 14 + 7$ of A_{ab} , with 14 corresponding to the adjoint and 7 to the fundamental representation of G_2 . This implies that A_{ab} can be decomposed as

$$A_{ab} = A_{ab}^+ + A_{ab}^-, \quad (5.3)$$

corresponding to 14 and 7, respectively. These components are explicitly

$$A_{ab}^+ = \frac{2}{3}(A_{ab} + \frac{1}{4}c_{abcd}A_{cd}), \quad (5.4)$$

$$A_{ab}^- = \frac{1}{3}(A_{ab} - \frac{1}{2}c_{abcd}A_{cd}). \quad (5.5)$$

In particular, the spin connection ω_{ab} of a given seven-dimensional metric can be expressed as $\omega_{ab} = (\omega_{ab})_+ + (\omega_{ab})_-$ in the same way as (5.3). This induce a decomposition of the form (5.2) for the Levi-Civita connection, the torsion part being related to $(\omega_{ab})_-$. When this component is zero, then the torsion will also vanish and the holonomy will be in G_2 .

Although the torsion may be interpreted as an obstruction of the holonomy to be reduced, the following detail should be remarked. Even in the case when the forms σ_p^G corresponding to a G structure are not covariantly constant, it may be incorrect to conclude that the holonomy is not reduced. As there is a local $SO(n)$ freedom for choosing the frame e^a , it may be the case that by a suitable rotation of the e^a one may construct a new G structure corresponding to the same metric and which, in addition, is covariantly constant. Thus, the holonomy will be G although the initial structure was not preserved by the Levi-Civita connection. An useful criteria for deciding whether or not a given metric is of G holonomy is the fact that metrics with reduced holonomy are always Ricci-flat or Einstein. This criteria is independent on the choice of the G structure.

In addition to the G_2 case discussed above, other well-known example of Ricci-flat manifolds of reduced holonomy are hyper-Kahler ones, which encode several non-compact gravitational instantons and also K_3 surfaces. By definition a hyper-Kahler manifold is $4n$ dimensional and admits a metric g_{4n} whose holonomy group is in $Sp(n)$. For these manifolds, there always exist a triplet J_i ($i = 1, 2, 3$) of $(1, 1)$ tensors with quaternion multiplication rule $J^i J^j = \delta_{ij} I + \epsilon_{ijk} J^k$ such that the metric is Hermitian with respect to any of them. The Lie algebra $sp(n)$ of $Sp(n)$ is generated by $(1, 1)$ tensors A of $so(4n)$ which commute with the J^i , i.e., satisfying $[A, J_i] = 0$. In other words, the action of $Sp(n)$ leave the tensors J_i invariant. The generalization of the discussion given in the previous paragraph implies that when

$$\nabla_X J^i = 0, \quad (5.6)$$

the holonomy will be included in $Sp(n)$. The last formula together with $\nabla_X g = 0$ imply that the $Sp(n)$ invariant 2-forms $\omega_i(X, Y) = g(X, J^i Y)$ are also covariantly constant with respect to the Levi-Civita connection. These are known as Kahler forms, and this condition implies that the metric is Kahler with respect to any of the ω_i . It can be shown that this system is equivalent to $d\omega_i = 0$, and the ω_i together with the metric g_{4n} compose the $Sp(n)$ structure.

For the Einstein case, the classical examples are quaternion Kahler manifolds of dimension higher than four, which are $4n > 4$ dimensional manifolds endowed with a metric g_{4n} whose holonomy is in $Sp(n) \times Sp(1) \in SO(4n)$.^{79,80} The set J_i together with the set A satisfying that $[A, J_i] = 0$ are the generators of the Lie algebra $sp(n) \oplus sp(1)$, and the action of $Sp(n)$ leave the J^i invariant but the action of $Sp(1)$ mix them due to the non-trivial commutator $[J^i, J^j] = \epsilon_{ijk} J^k$. As a result,

520 if the condition

$$\nabla_X J^i = \epsilon_{jk}^i J^j \tilde{\omega}_-^k, \quad \nabla_X \omega^i = \epsilon_{jk}^i \omega^j \tilde{\omega}_-^k, \quad (5.7)$$

521 then the manifold will have holonomy in $Sp(n) \times Sp(1)$. Here, $\tilde{\omega}_-^k$ is the $Sp(1)$ part of the connection.
 522 In different way than for hyper-Kähler manifolds, in the quaternionic case the triplet of 2-forms ω_i
 523 are not covariantly constant. Still their specific behavior (5.7) imply a reduction of the holonomy
 524 from $SO(4n)$ to $Sp(n) \times Sp(1)$. Alternatively, it may be shown that the condition for being quaternion
 525 Kähler imply that

$$d\omega^i = \epsilon_{jk}^i \omega^j \wedge \tilde{\omega}_-^k, \quad d\Omega = 0, \quad (5.8)$$

526 where the 4-form $\Omega = \omega_1 \wedge \omega_1 + \omega_2 \wedge \omega_2 + \omega_3 \wedge \omega_3$ has been introduced. The $Sp(n) \times Sp(1)$
 527 structure is composed by the metric, the three 2-forms ω_i and the 4-form Ω .

528 A. A check of the Papadopoulos list

529 The present subsection deals with the problem of classifying which G structures do admit some
 530 of their G invariant p-forms σ_p^G as Killing-Yano tensors. This was investigated already in Ref. 73
 531 with G being the Berger groups. The purpose of the present section is to reproduce by use of the
 532 torsion languages developed in Refs. 82–92. The Killing-Yano condition (3.2) is translated for σ_p^G
 533 as

$$\nabla_X \sigma_p^g = \frac{1}{p+1} i_X d\sigma_p^g. \quad (5.9)$$

534 All the forms σ_p^g composing a Ricci-flat structure are Killing-Yano, as both the left and the right
 535 hand side vanish identically. Our task is to find non-trivial examples, when possible. The left hand
 536 side of the last equation involves the torsion T_{jk}^i introduced (5.2). The right hand is also determined
 537 in terms of T_{ij}^k by the well-known formula

$$d\Lambda = \frac{1}{(p-1)!} \nabla_{[\mu_1} \Lambda_{\mu_2 \dots \mu_p]} dx^1 \wedge \dots \wedge dx^p, \quad (5.10)$$

538 together with (5.2). Therefore, the Killing-Yano equation is essentially reduced to a constraint for
 539 the torsion. The interesting point is that several solutions for these constraints involve structures
 540 which are relevant for constructing supergravity solutions with conformal field theory duals. The
 541 task to find hidden symmetries in these structures is therefore of theoretical interest.

542 1. Kähler and Calabi-Yau structures

543 Consider first $U(n)$ structures, which are defined in $d = 2n$ dimensions.⁸⁶ These are composed
 544 by a $2n$ -dimensional metric g defined over a manifold M_{2n} and an almost complex structure J . The
 545 last is an automorphism of the cotangent space satisfying the complex imaginary unit multiplication
 546 rule $J^2 = -I_{2n \times 2n}$, and the metric g is assumed to be Hermitian with respect to it. The Hermiticity
 547 condition means that the tensor $\omega(X, Y) = g(X, JY)$ is a 2-form, commonly known as almost Kähler
 548 form. The Nijenhuis tensor corresponding to J may be expressed as

$$N_{\mu\nu}^\rho = J_\mu^\lambda (\partial_\lambda J_\nu^\rho - \partial_\nu J_\lambda^\rho) - J_\nu^\lambda (\partial_\lambda J_\mu^\rho - \partial_\mu J_\lambda^\rho), \quad (5.11)$$

549 and the vanishing of this tensor implies that M_{2n} is complex with respect to J . If in addition there
 550 exists a connection $\nabla^{u(n)}$ with torsion for which $\nabla^{u(n)}g = \nabla^{u(n)}J = 0$, then the Nijenhuis tensor may
 551 be expressed entirely in terms of J and the torsion. This condition is explicitly

$$\nabla_\mu^{u(n)} J_\nu^\rho = \partial_\mu J_\nu^\rho + \gamma_{\lambda\mu}^\rho J_\nu^\lambda - \gamma_{\nu\mu}^\lambda J_\lambda^\rho = 0, \quad (5.12)$$

552 with $\gamma_{\mu\nu}^\rho$ defined in terms of the Christoffel symbols $\Gamma_{\mu\nu}^\rho$ and the torsion $T_{\mu\nu}^\rho$ as follows:

$$\gamma_{\mu\nu}^\rho = \Gamma_{\mu\nu}^\rho - \frac{1}{2} T_{\mu\nu}^\rho. \quad (5.13)$$

From (5.12) and (5.13), it follows that (5.11) can be expressed as

$$N_{\mu\nu}^{\rho} = T_{\mu\nu}^{\rho} - J_{\mu}^{\lambda} J_{\nu}^{\sigma} T_{\lambda\sigma}^{\rho} + (J_{\mu}^{\lambda} T_{\lambda\nu}^{\sigma} - J_{\nu}^{\lambda} T_{\lambda\mu}^{\sigma}) J_{\sigma}^{\rho}, \tag{5.14}$$

which express the Nijenhuis tensor entirely in terms of the torsion and the almost complex structure. The decomposition $so(2n) = u(n) \oplus u(n)^{\perp}$ induce a decomposition of the space Λ^2 of 2-forms on M_{2n} as

$$\frac{1}{2}2n(2n - 1) \longrightarrow n^2 \oplus \frac{1}{2}n(n - 1) \oplus \overline{\frac{1}{2}n(n - 1)}. \tag{5.15}$$

This can be expressed as $\Lambda^2 = \Lambda^{(1,1)} \oplus \Lambda^{(2,0) + (0,2)}$. Denote as Υ_{ijk} the following covariant derivatives:

$$\nabla_i \omega_{jk} = \Upsilon_{i,jk}. \tag{5.16}$$

The torsion belongs to $T^*M \otimes u(n)^{\perp}$ and by representing the cotangent space as $T^*M = T^{*(1,0)}M \oplus T^{*(0,1)}M$ and taking into account (5.15), it follows that the non-zero covariant derivatives are

$$\Upsilon_{\alpha,\beta\gamma}, \quad \Upsilon_{\alpha,\bar{\beta}\bar{\gamma}}, \quad \Upsilon_{\bar{\alpha},\beta\gamma}, \quad \Upsilon_{\bar{\alpha},\bar{\beta}\bar{\gamma}}. \tag{5.17}$$

These components can be divided into four irreducible representations W_i with $i = 1, \dots, 4$ of $T^*M \otimes u(n)^{\perp}$ on $u(n)$ given by Ref. 129,

$$\begin{aligned} (W_1)_{\bar{\alpha}\bar{\beta}\bar{\gamma}} &= \Upsilon_{[\bar{\alpha},\bar{\beta}\bar{\gamma}]}, & (W_2)_{\bar{\alpha}\bar{\beta}\bar{\gamma}} &= \Upsilon_{\bar{\alpha},\bar{\beta}\bar{\gamma}} - \Upsilon_{[\bar{\alpha},\bar{\beta}\bar{\gamma}]} \\ (W_3)_{\bar{\alpha}\beta\gamma} &= \Upsilon_{\bar{\alpha},\beta\gamma} - \frac{2}{n-1} \Upsilon_{\bar{\mu},[\gamma} g_{\beta]\bar{\alpha}}, & (W_4)_{\gamma} &= \Upsilon_{\bar{\mu},\gamma}^{\bar{\mu}}. \end{aligned} \tag{5.18}$$

The component W_3 is traceless.

For $SU(n)$ structures one has, in addition to the Kahler form ω , an invariant $(n, 0)$ form Ω whose square is proportional to the volume form of g , namely,

$$(-1)^{\frac{n(n-1)}{2}} \left(\frac{i}{2}\right)^n \Omega \wedge \bar{\Omega} = \frac{1}{n!} \omega^n = dvol(g). \tag{5.19}$$

The additional covariant derivative

$$\nabla_{\bar{\alpha}} \Omega_{\beta\gamma\delta\rho} = (W_5)_{\bar{\alpha}\beta\gamma\delta\rho}, \tag{5.20}$$

determines a new class W_5 .

The $SU(3)$ case is of particular importance in the context of compactifications of II supergravity down to four dimensions. These structures are classified as follows. As the components of the Nijenhuis tensor are expressed entirely in terms W_1 and W_2 , when these torsion components are zero the manifold is complex. Particular subcases are structures for which the unique non-vanishing classes are W_3 and W_5 which are known as balanced. When W_3 is the unique non-vanishing torsion the structure is known as special Hermitian, while when W_5 is the only non-vanishing component the structure is Kahler. Other important examples are those for which $\partial\bar{\partial}J = 0$ and $dJ \neq 0$ which are known as strong Kahler structures. If instead W_1 or W_2 are not zero, then the manifold is non-complex. When W_1 is the unique non-zero component, the manifold is known as nearly Kahler. When W_2 is the unique non-zero component, then the manifold is known as almost Kahler. Finally, when the torsion belongs to $W_1^- \oplus W_2^- \oplus W_3$ the manifold is known as half flat.

The torsion classes W_i not only determine the covariant derivatives of $\omega(X, Y)$ and of Ω , but also their differentials $d\omega$ and $d\Omega$.⁹¹ This follows from the elementary formula (5.10) and the final result for $SU(n)$ structures may be schematically stated as

$$\begin{aligned} W_1 &\longleftrightarrow d\omega^{(3,0)} + d\omega^{(0,3)}, \\ W_3 + W_4 &\longleftrightarrow d\omega^{(2,1)} + d\omega^{(1,2)}, \\ W_1 + W_2 &\longleftrightarrow d\Omega^{(n-1,2)} + d\Omega^{(2,n-1)}, \\ W_4 + W_5 &\longleftrightarrow d\Omega^{(n,1)} + d\Omega^{(1,n)}. \end{aligned} \tag{5.21}$$

586 For example, the first (5.21) is explicitly

$$d\omega^{(3,0)} + d\omega^{(0,3)} = 3W_1. \quad (5.22)$$

587 By comparing this formula with the first (5.18), it follows easily that when $W_2 = W_3 = W_4 = W_5$
588 $= 0$ one has that

$$\nabla_X \omega = \frac{1}{3} i_X d\omega, \quad (5.23)$$

589 and this implies that for these types of manifolds the almost Kahler form ω is a Killing-Yano tensor.
590 As it was discussed above, structures with these types of torsion are nearly Kahler.⁸³ These manifolds
591 are characterized by the condition $\nabla_X J(X) = 0$ and some applications in physics can be found in
592 Refs. 93–95. Additionally, the last (5.21) together with the definition (5.20) shows that when
593 $W_4 = W_5 = 0$ the components $\Omega^{(n,1)}$ and $\Omega^{(1,n)}$ are covariantly constant, thus Killing-Yano. These
594 structures are balanced and Hermitian.

595 2. Quaternion Kahler and hyper-Kahler structures

596 The next structures we would like to consider are $Sp(n) \times Sp(1)$ ones, which are known as
597 quaternion Kahler. In this case, the p-forms defining the structure are the triplet of almost Kahler
598 2-forms ω_i together with the 4-form

$$\Omega = \omega_1 \wedge \omega_1 + \omega_2 \wedge \omega_2 + \omega_3 \wedge \omega_3. \quad (5.24)$$

599 For these structures, there exist an useful formula derived in the Proposition 4.3 of Ref. 87 which
600 relate the covariant derivatives of the almost Kahler forms ω_i with their differentials. The explicit
601 form of this formula is

$$\begin{aligned} \nabla_X \omega_1(Y, Z) &= d\omega_1(X, Y, Z) - d\omega_1(X, J^1 Y, J^1 Z) + d\omega_2(J^2 X, Y, Z) + d\omega_2(J^2 X, J^1 Y, Z) \\ &+ d\omega_2(J^2 X, Y, J^1 Z) + d\omega_3(J^2 X, Y, Z) - d\omega_3(J^2 X, J^1 Y, J^1 Z), \end{aligned} \quad (5.25)$$

602 and the analogous formula holds for cyclic permuted indices. Clearly, if ω_1 is required to be Killing-
603 Yano, then (5.9) implies that $d\omega_2 = d\omega_3 = 0$. Furthermore, $3d\omega_1(X, J^1 Y, J^1 Z) = -2d\omega(X, Y, Z)$.
604 But if two of the almost Kahler form are required to be simultaneously Killing-Yano, then the same
605 analysis shows that $d\omega_1 = d\omega_2 = d\omega_3$. Therefore, if these forms are Killing-Yano then the metric is
606 hyper-Kahler and thus the holonomy is $Sp(n)$ or even a smaller subgroup. In addition, the covariant
607 derivatives of the 4-form (5.24) can be calculated by direct use of (5.25), the result is given in the
608 formula (5.1) of Ref. 88

$$\nabla \Omega = 2\epsilon_{ijk} \alpha_{[kj]} \wedge \omega_i. \quad (5.26)$$

609 In formula (5.26), the tensor α_{kj} has been introduced, and is explicitly

$$\alpha_{kj}(X, Y, Z) = \alpha_k(X, J^j Y, Z), \quad (5.27)$$

610 with

$$\alpha_i = -\lambda_i \otimes g + \frac{\epsilon_{ijk}}{4} \left(\nabla \omega_k(\cdot, J^j \cdot, \cdot) - \nabla \omega_k(\cdot, \cdot, J^j \cdot) \right).$$

611 In the last formula, the 1-forms λ_i are expressed as

$$\lambda_1(X) = \frac{1}{2n} \langle \nabla_X \omega_2, \omega_3 \rangle,$$

612 up to cyclic permutations. We see from (5.26) that Ω is a Killing-Yano tensor when Ω is covariantly
613 constant. Thus, the metric is quaternion Kahler for this to be the case.

614 3. Spin(7) structures

615 Other structures with particular physical interest are the $Spin(7)$ structures.⁹⁰ These are defined
616 on eight-dimensional manifolds with metric $g_8 = \delta_{ab} e^a \otimes e^b$. The holonomy will be in $Spin(7)$ if the

following octonionic form

$$\Phi = e^8 \wedge \phi + *7\phi \tag{5.28}$$

is closed. Here, $\phi = c_{abc}e^a \wedge e^b \wedge e^c$ and c_{abc} are the multiplication constants of the imaginary octonions. This form satisfy the self-duality condition $*\Phi = \Phi$. In addition, we have that

$$d\Phi = \theta \wedge \Phi + W_1, \tag{5.29}$$

that is the differential of Φ has a part which is proportional to Φ and a part W_1 which is not. The form θ is known as the Lee form. The covariant derivative of the fundamental 4-form is

$$\nabla_m \Phi_{ijkl} = T_{mip}g^{pq}\Phi_{qjkl} + T_{mjp}g^{pq}\Phi_{iqkl} + T_{mkp}g^{pq}\Phi_{jiql} + T_{mlp}g^{pq}\Phi_{jklq}, \tag{5.30}$$

with T given by

$$T = -*d\Phi - \frac{7}{6}*(\theta \wedge \Phi). \tag{5.31}$$

By checking explicitly the condition (5.9) in this situation, we were able to find a solution only when $d\Phi = \nabla\Phi = 0$. This corresponds to manifolds with holonomy in $Spin(7)$.

4. G_2 structures

Let us now analyze the presence of Killing-Yano tensors on G_2 structures $(\phi, *\phi)$.^{84,89} In this case, one may find non-trivial examples, as it will be seen below. The torsion classes τ_i for the differential are given by⁹¹

$$d\phi = \tau_0 * \phi + 3\tau_1 \wedge \phi + *\tau_2, \tag{5.32}$$

$$d * \phi = 4\tau_1 \wedge *\phi + *\tau_3.$$

When the torsion classes vanish, the holonomy will be G_2 or a subgroup of G_2 . The covariant derivative of the 3-form can be expressed as⁹²

$$\nabla_l \phi_{abc} = T_{lm}g^{mn}(*\phi)_{nabc}, \tag{5.33}$$

with the torsion tensor given by

$$T_{lm} = \frac{\tau_0}{4}g_{lm} - (\tau_3)_{lm} + (\tau_1)_{lm} - (\tau_2)_{lm}. \tag{5.34}$$

The Killing-Yano condition $4\nabla_X\phi = i_X d\phi$ implies $i_X \nabla_X \phi = 0$. This together with (5.33) and (5.34) show that for ϕ being a Killing-Yano tensor only a non-zero τ_0 component is allowed. These structures are known as nearly parallel. Thus, for every nearly parallel G_2 structure the octonionic 3-form ϕ is a non-trivial Killing-Yano tensor of order three.

B. Further examples

1. Almost contact structures

The calculations performed above show the validity of the Papadopoulos list for Killing-Yano tensors in G structures of the Berger type. Below we will focus on cases which are not of this type, and which consequently do not appear in the Papadopoulos list. This is the case for the almost contact structures.

Almost contact structures are defined in $d = 2n + 1$ dimensions¹¹⁴ and are intimately ligated to almost Kahler structures in dimension $d = 2n + 2$. In fact, the cone of an almost contact structure defines an almost Kahler structure and when the structure is Kahler the almost contact structure is known as Sasakian. Sasakian structures are reviewed for instance in Refs. 96–101. When the Kahler cone metric is Ricci-flat, thus Calabi-Yau, then the odd dimensional metric is known as Einstein-Sasaki.

In formal terms, an almost contact structure is a $U(n) \times 1 \in SO(2n + 1)$ structure. It is composed by a metric g_{2n+1} defined over a space M_{2n+1} together with a selected vector field

651 $\xi \in TM_{2n+1}$ whose dual form will be denoted as $\eta \in T^*M_{2n+1}$, and a morphism $\phi: TM_{2n+1}$
 652 $\rightarrow TM_{2n+1}$ satisfying the conditions

$$g_{2n+1}(\phi X, \phi Y) = g_{2n+1}(X, Y) - \eta(X) \otimes \eta(Y),$$

653

$$\phi^2 = -I + \eta \otimes \xi. \quad (5.35)$$

654 The fundamental form for this structure is $\Phi = g_{2n+1}(X, \phi Y)$. The cone over an almost contact
 655 structure,

$$g_{2n+2} = dr^2 + r^2 g_{2n+1}, \quad (5.36)$$

656 is defined over $M_{2n+2} = R_{>0} \times M_{2n+1}$. This manifold admits an almost complex structure J
 657 described by the following actions:

$$J\partial_r = -\frac{1}{r}\xi, \quad JX = \phi X + r\eta(X)\partial_r. \quad (5.37)$$

658 By decomposing a vector field $\tilde{X} \in R_{>0} \times M_{2n+1}$ into a radial and angular part as $\tilde{X} = (a, X)$, it is
 659 found from (5.35) and (5.37) that the action of the almost complex structure over \tilde{X} is

$$J(a, X) = (r\eta(X), \phi X - \frac{a}{r}\xi). \quad (5.38)$$

660 The lifted Levi-Civita connection $\tilde{\nabla}$ over the cone is defined through

$$\tilde{\nabla}_{\partial_r}\partial_r = 0, \quad \tilde{\nabla}_X\partial_r = \tilde{\nabla}_{\partial_r}X = \frac{X}{r},$$

661

$$\tilde{\nabla}_X Y = \nabla_X Y - r g(X, Y)\partial_r. \quad (5.39)$$

662 Here, ∇ is the Levi-Civita connection for the metric g_{2n+1} of the almost contact structure. From
 663 (5.39) and (5.37), it is deduced that

$$(\tilde{\nabla}_{\partial_r}J)\partial_r = (0, 0), \quad (\tilde{\nabla}_{\partial_r})X = (0, 0),$$

664

$$(\nabla_X J)\partial_r = (0, \frac{1}{r}(-\nabla_X \xi + \phi X)), \quad (5.40)$$

665

$$(\tilde{\nabla}_X J)Y = (r\nabla_X \eta(Y) - r g_{2n+1}(X, \phi Y), (\nabla_X \phi)Y - g_{2n+1}(X, Y)\xi + \eta(Y)X).$$

666 The Kahler condition is equivalent to the vanishing of all the covariant derivatives (5.40) and this
 667 holds when

$$\nabla_X \xi = \phi X,$$

668

$$\nabla_X \eta(Y) = g_{2n+1}(X, \phi Y), \quad (5.41)$$

669

$$(\nabla_X \phi)Y = g_{2n+1}(X, Y)\xi - \eta(Y)X.$$

670 The last three conditions define a Sasakian structure. Alternatively, the second (5.41) implies that ξ
 671 is Killing and the first and the third ones may combine to obtain

$$\nabla_X(d\eta) = -2X^* \wedge \eta. \quad (5.42)$$

672 This equation implies in particular that $d^*d\eta = (n-1)\eta$ and, by taking this into account, it follows
 673 that (5.42) can be expressed as

$$\nabla_X(d\eta) = -\frac{1}{n-1}X^* \wedge d^*d\eta. \quad (5.43)$$

674 Since $d\eta$ is closed the last equation shows that $d\eta$ is a conformal Killing tensor.¹²⁶ This, together
 675 with the fact that η is also a conformal Killing 1-form, implies that the combinations

$$\omega_k = \eta \wedge (d\eta)^k, \quad (5.44)$$

676 are all Killing tensors of order $2k+1$.¹²⁶

There exist other almost contact structures, different from Sasaki ones, which also admit Killing-Yano tensors. Generic almost contact structures are characterized by the irreducible components of the covariant derivative $\nabla\Phi$ of the fundamental form.^{103,104} In representation theoretical terms this derivative belongs to $T^*M \otimes u(n)^\perp$. One may decompose the cotangent space as

$$T^*M = R\eta + \eta^\perp, \tag{5.45}$$

from where it follows that

$$\begin{aligned} so(2n + 1) &\simeq \Lambda^2 T^*M = \Lambda^2 \eta^\perp + \eta^\perp \wedge R\eta \\ &= u(n) + u(n)^\perp_{|\xi^\perp} + \eta^\perp \wedge R\eta. \end{aligned} \tag{5.46}$$

From (5.46), it is obtained that

$$u(n)^\perp = u(n)^\perp_{|\xi^\perp} + \eta^\perp \wedge R\eta. \tag{5.47}$$

Therefore, the covariant derivative $\nabla\Phi$ belongs to

$$\begin{aligned} \nabla\Phi \in T^*M \otimes u(n)^\perp &= \eta^\perp \otimes u(n)^\perp_{|\xi^\perp} + \eta \otimes u(n)^\perp_{|\xi^\perp} \\ &+ \eta^\perp \otimes \eta^\perp \wedge \eta + \eta \otimes \eta^\perp \wedge \eta. \end{aligned} \tag{5.48}$$

The respective components are

$$\nabla_i \phi_{jk}, \quad \nabla_m \phi_{jk}, \quad \nabla_i \phi_{mk}, \quad \nabla_m \phi_{mk}, \tag{5.49}$$

with the indices i, j, k corresponding to the η^\perp directions and m to the η direction. But these components are not irreducible, and in fact it was shown in Refs. 103 and 104 that there is a further decomposition into 12 irreducible classes given schematically as

$$\begin{aligned} \eta^\perp \otimes u(n)^\perp_{|\xi^\perp} &= C_1 + C_2 + C_3 + C_4, \\ \eta^\perp \otimes \eta^\perp \wedge \eta &= C_5 + C_6 + C_7 + C_8 + C_9 + C_{10}, \\ \eta \otimes u(n)^\perp_{|\xi^\perp} &= C_{11}, \quad \eta \otimes \eta^\perp \wedge \eta = C_{12}. \end{aligned} \tag{5.50}$$

More precisely, the space $C(V)$ of 3-form tensors with the same symmetries of $\nabla\Phi$ is

$$C(V) = \{T \in \otimes_3 V \mid T(x, y, z) = -T(x, z, y) = -T(x, \phi y, \phi z) + \eta(y)T(x, \xi, z) + \eta(z)T(x, y, \xi)\},$$

and can be decomposed as

$$C(V) = \bigoplus_{i=1}^{12} C_i(V),$$

with the irreducible components $C_i(V)$ given by

$$C_1(V) = \{T \in C(V) \mid T(x, x, y) = -T(x, y, \xi) = 0\},$$

$$C_2(V) = \{T \in C(V) \mid T(x, y, z) + T(y, z, x) + T(z, x, y) = 0, \quad T(x, y, \xi) = 0\},$$

$$C_3(V) = \{T \in \otimes_3 V \mid T(x, y, z) = T(\phi x, \phi y, z), \quad \sum c_{12} T(x) = 0\},$$

$$\begin{aligned} C_4(V) = \{T \in \otimes_3 V \mid T(x, y, z) = \frac{1}{2n-1} \left[(g(x, y) - \eta(x)\eta(y))c_{12}T(z) \right. \\ \left. - \frac{1}{2n-1} (g(x, z) - \eta(x)\eta(z))c_{12}T(y) - g(x, \phi y)c_{12}T(\phi z) \right. \\ \left. + g(x, \phi z)c_{12}T(\phi y) \right], \quad c_{12}T(\xi) = 0\}, \end{aligned}$$

$$C_5(V) = \{T \in \otimes_3 V \mid T(x, y, z) = \frac{1}{2n} \left[g(x, \phi z) \eta(y) \bar{c}_{12} T(\phi \xi) - g(x, \phi y) \eta(z) \bar{c}_{12} T(\phi \xi) \right]\},$$

$$C_6(V) = \{T \in \otimes_3 V \mid T(x, y, z) = \frac{1}{2n} \left[g(x, y) \eta(z) c_{12} T(\xi) - g(x, z) \eta(y) c_{12} T(\phi \xi) \right]\},$$

$$C_7(V) = \{T \in \otimes_3 V \mid T(x, y, z) = T(y, x, \xi) \eta(z) - T(\phi x, \phi z, \xi) \eta(y), \quad c_{12} T(\xi) = 0\},$$

$$C_8(V) = \{T \in \otimes_3 V \mid T(x, y, z) = -T(y, x, \xi) \eta(z) - T(\phi x, \phi z, \xi) \eta(y), \quad \bar{c}_{12} T(\xi) = 0\},$$

$$C_9(V) = \{T \in \otimes_3 V \mid T(x, y, z) = T(y, x, \xi) \eta(z) + T(\phi x, \phi z, \xi) \eta(y)\},$$

$$C_{10}(V) = \{T \in \otimes_3 V \mid T(x, y, z) = -T(y, x, \xi) \eta(z) + T(\phi x, \phi z, \xi) \eta(y)\},$$

$$C_{11}(V) = \{T \in \otimes_3 V \mid T(x, y, z) = -T(\xi, \phi y, \phi z) \eta(x)\},$$

$$C_{12}(V) = \{T \in \otimes_3 V \mid T(x, y, z) = -T(\xi, \xi, z) \eta(x) \eta(y) - T(\xi, y, \xi) \eta(x) \eta(z)\},$$

where the following quantities

$$c_{12} T(x) = \sum T(e_i, e_i, x),$$

$$\bar{c}_{12} T(x) = \sum T(e_i, \phi e_i, x),$$

have been introduced, with e^i an arbitrary orthonormal basis.

It should be remarked that some of the classes C_i may vanish for lower enough dimensions. For $n = 1$, the covariant derivative $\nabla \Phi$ belongs to $C_5 \oplus C_6 \oplus C_9 \oplus C_{12}$. The case $n = 2$ corresponds to the structures studied in Refs. 120 and 121, and for this dimension almost contact structures belongs to $C_2 \oplus C_4 \oplus C_6 \oplus C_8 \oplus C_{10} \oplus C_{12}$. Only for $n \geq 3$ all the classes may not vanish.

The classification of the structures goes as follows. When all the classes vanish the structure is known as cosymplectic, C_1 structures are nearly K-cosymplectic, C_5 are α -Kenmotsu manifolds, C_6 are α -Sasakian and in particular, Sasakian structures belong to this class. Other structures are $C_5 \oplus C_6$ which are known as trans-Sasakian, $C_2 \oplus C_9$ which are almost cosymplectic, $C_6 \oplus C_7$ which are quasi-Sasakian, $C_1 \oplus C_5 \oplus C_6$ which are nearly trans-Sasakian and $C_1 \oplus C_2 \oplus C_9 \oplus C_{10}$ which are quasi K-cosymplectic and $C_3 \oplus C_4 \oplus C_5 \oplus C_6 \oplus C_7 \oplus C_8$ which are normal ones. Properties of these structures may be found in Refs. 105 and 106 and references therein.

The class for which Φ is Killing-Yano is the one for which $\nabla \Phi$ is totally antisymmetric, and this is the case when the unique non-vanishing class is C_1 . Therefore, for nearly K-cosymplectic structures are the ones for which the fundamental form Φ is a Killing-Yano tensor of order two. These structures are characterized by the condition $\nabla_X \phi X = 0$, i.e., $\nabla_X \phi Y + \nabla_Y \phi X = 0$. Properties of these structures were studied for instance in Refs. 107–113.

2. $SO(3)$ structures in $SO(5)$ and higher dimensional generalizations

Let us consider now $SO(3)$ structures in five dimensions. Given a five-dimensional manifold M_5 with a metric g_5 an $SO(3)$ structure is the reduction of the frame bundle to a $SO(3)$ sitting in $SO(5)$.¹¹⁵ One has the decomposition $so(5) = so(3) \oplus V$ with V the unique seven-dimensional fundamental representation of $so(3)$. The space R^5 is isomorphic to space of 3×3 symmetric traceless matrices $S_0^2 R^3$, the isomorphism can be expressed by means of the mapping

$$(x_1, x_2, x_3, x_4, x_5) \longleftrightarrow X = \begin{pmatrix} \frac{x_1}{\sqrt{3}} - x_4 & x_2 & x_3 \\ x_2 & \frac{x_1}{\sqrt{3}} + x_4 & x_5 \\ x_3 & x_5 & -\frac{2x_1}{\sqrt{3}} \end{pmatrix}. \quad (5.51)$$

These matrices define the unique irreducible representation ρ of $SO(3)$ in R^5 given as follows: 729

$$\rho(h)X = hXh^{-1}, \quad h \in SO(3). \quad (5.52)$$

For an element X , its characteristic polynomial $P_X(\lambda)$ invariant under the action of ρ , i.e, $P_{\rho(h)X}(\lambda)$ 730
 $= P_X(\lambda)$, is given by 731

$$P_X(\lambda) = \det(X - \lambda I) = -\lambda^3 + g(X, X)\lambda + \frac{2\sqrt{3}}{9}\Upsilon(X, X, X), \quad (5.53)$$

with 732

$$g(X, X) = x_1^2 + x_2^2 + x_3^2 + x_4^2 + x_5^2,$$

$$\Upsilon(X, X, X) = \frac{3\sqrt{3}}{2} \det X = \frac{x_1}{2}(6x_1^2 + 6x_2^2 - 2x_3^2 - 3x_4^2 - 3x_5^2) + \frac{3\sqrt{3}x_4}{2}(x_5^2 - x_3^2) + 3\sqrt{3}x_2x_3x_5. \quad (5.54)$$

By introducing a 3-tensor Υ_{ijk} by the relation $\Upsilon(X, X, X) = \Upsilon_{ijk}x_i x_j x_k$, it follows that 734

$$\Upsilon_{ijk} = \Upsilon_{(ijk)},$$

$$\Upsilon_{ijj} = 0, \quad (5.54)$$

$$\Upsilon_{jki}\Upsilon_{lni} + \Upsilon_{lji}\Upsilon_{kni} + \Upsilon_{kli}\Upsilon_{jni} = g_{jk}g_{ln} + g_{lj}g_{kn} + g_{kl}g_{jn},$$

where the tensor g_{ij} is defined through the relation $g(X, X) = g_{ij}x_i x_j$. In these terms for a given 737
manifold M_5 with a metric g_5 , an $SO(3)$ structure is given in terms of a tensor Υ of rank three for 738
which the associated linear map constructed in terms of $Z \in TM_5$ given by 739

$$\Upsilon_{ij} = (\Upsilon_{ij}^k Z_k) \in \text{End}(TM_5),$$

satisfying the following conditions: 740

$$\text{Tr}(\Upsilon_Z) = 0,$$

$$g(X, \Upsilon_Z Y) = g(Z, \Upsilon_Y X) = g(Y, \Upsilon_X Z), \quad (5.55)$$

$$\Upsilon_Z^2 Z = g(Z, Z)Z. \quad (5.56)$$

There always exist a basis e^a such that 743

$$g_5(X, X) = e^1 \otimes e^1 + e^2 \otimes e^2 + e^3 \otimes e^3 + e^4 \otimes e^4 + e^5 \otimes e^5, \quad (5.56)$$

which is defined up to an $SO(3)$ transformation $\tilde{e}^a = \rho(h)e^a$, and such that 744

$$\begin{aligned} \Upsilon = & \frac{e^1}{2} \otimes (6e^1 \otimes e^1 + 6e^2 \otimes e^2 - 2e^3 \otimes e^3 - 3e^4 \otimes e^4 - 3e^5 \otimes e^5) \\ & + \frac{3\sqrt{3}e^4}{2} \otimes (e^5 \otimes e^5 - e^3 \otimes e^3) + 3\sqrt{3}e^2 \otimes e^3 \otimes e^5. \end{aligned}$$

This defines a $SO(3)$ structure over (M_5, g_5) . 745

The types of possible $SO(3)$ structures are defined in terms of the covariant derivative of Υ_{ijk} . The 746
situation is different from the other G structures considered above, as this tensor is totally symmetric, 747
and one may try to study in which situations Υ_{ijk} is a Killing tensor instead a Killing-Yano one. The 748
Killing condition $\nabla_{(i}\Upsilon_{jkl)}$ can be rewritten as 749

$$\nabla_X \Upsilon(X, X, X) = 0. \quad (5.57)$$

Fortunately, structures satisfying this condition have been considered in Refs. 116 and 117 and we 750
can just borrow the description from that references. The condition (5.57) resembles the nearly 751
Kahler one $\nabla_X J(X) = 0$, and for this reason $SO(3)$ structures satisfying this condition are known as 752

753 nearly integrable in the terminology of Refs. 116 and 117. For example, there exist only three nearly
754 integrable structures with eight-dimensional symmetry groups

$$M_+ = SU(3)/SO(3), \quad M_0 = (SO(3) \times_{\rho} R^5)/SO(3), \quad M_- = SL(3, R)/SO(3).$$

755 Further examples with the symmetry and lower dimensional groups were found in Refs. 116 and
756 117 and on five-dimensional Lie groups in Ref. 119.

757 In addition to these examples, it was shown in Ref. 118 that tensors satisfying the conditions
758 (5.54) exist in distinguished dimensions $n_k = 3k + 2$, where $k = 1, 2, 4, 8$, as observed also
759 by Bryant. The numbers $k = 1, 2, 4, 8$ are the dimensions of the division algebras and in these
760 dimensions the orthogonal group may be reduced to the subgroups $H_k \subset SO(n_k)$, with $H_1 = SO(3)$,
761 $H_2 = SU(3)$, $H_4 = Sp(3)$, and $H_8 = F_4$. Nearly, integrable geometries can be defined in all these
762 dimensions by the condition (5.57) and it turns out that for all these geometries Υ is a Killing tensor.
763 Examples of these geometries can be found in Ref. 118.

764 VI. DISCUSSION

765 In the present work, some of the applications of Killing-Yano tensors in general relativity and
766 supersymmetric quantum field theory have been reviewed. Additionally, the Papadopoulos list of G
767 structures whose G invariant tensors are Killing-Yano has been reproduced and enlarged to cases
768 which do not appear in the Berger list. It should be remarked that the results presented here about G
769 structures do not consist in a no go theorem. For instance, we have shown that between the $SU(3)$
770 structures, the nearly Kahler are the ones for which their almost Kahler 2-form is Killing-Yano. But
771 this does not imply the absence of Killing-Yano for other $SU(3)$ structures. In fact, the presence of
772 Killing-Yano tensors in half-flat manifolds, which are outside this classification, are under current
773 investigation.¹²² What the present work is showing is that for these other structures the presence of
774 a Killing-Yano tensor may be a special situation, while for the nearly Kahler case the presence of
775 hidden symmetries is something generic. The same considerations hold for the other G structures
776 studied.

777 The presence of these hidden symmetries in these structures can be of interest in the AdS/CFT
778 correspondence. For instance, we have shown that nearly Kahler, weak G_2 holonomy or Einstein-
779 Sasaki manifolds do admit non-trivial Killing-Yano tensors. The cones over these manifolds
780 are Ricci-flat and of holonomy G_2 , $Spin(7)$ and $SU(3)$ holonomy, respectively, and from these
781 manifolds one may construct ten-dimensional supergravity solutions whose near horizon lim-
782 its are the form $AdS_3 \times$ (weak G_2), $AdS_4 \times$ (nearly Kahler), and $AdS_5 \times$ (Einstein-Sasaki). In
783 some regimes, certain anomalous dimensions of the dual quantum field theories may be calcu-
784 lated by studying strings configuration over these backgrounds. The energy and the conserved
785 quantities for the movement of these strings give information about the anomalous dimensions
786 of the dual theory. It is even possible to draw conclusions about the dual theory by studying
787 particle limits of that string. For example, in Ref. 123 anomalous long Bogomoln'yi-Prasad-
788 Sommerfeld (BPS) operators are matched to massless point-like strings in AdS_5 backgrounds
789 with the Einstein-Sasaki spaces found in Ref. 124 as internal spaces, and the conserved charges
790 for that particle-like movement gives information about the anomalous dimensions of that oper-
791 ators. Thus, the presence of hidden symmetries in these backgrounds is of theoretical interest,
792 and it may be an interesting task to understand to which quantum numbers of the dual theory
793 these Killing-Yano tensors are matched with. Several of these are W-symmetries, as pointed out in
794 Ref. 73, but a more concrete description still is desirable.

795 Another interesting task could be to understand more deeply whether or not the relation between
796 the algebraic type of the curvature for a given space time and the presence of hidden symmetries,
797 which is known for Killing-Yano tensors of order two in four dimensions, can be generalized to
798 higher dimensions and for tensors of higher rank. In our opinion, these tasks are of theoretical interest
799 and deserve further attention.
